

## SUPPORTING CHILDREN'S ENOTIONAL REGULATION By Kelly Zelvis

Earlier this year, I had the opportunity to attend an informative workshop on Emotional Freedom Techniques (EFT) with Natalie from Divine EFT. As educators, nurturing emotional well-being in children is paramount, and I'm excited to share how EFT can be a transformative tool in our daily practice.

Led by Natalie, a Certified EFT Practitioner with a background in early childhood education, the workshop introduced us to the basics of EFT, emphasising its potential in supporting us as Educators and children's emotional regulation. One innovative method discussed was the use of 'tapping teddies.' These teddies serve as tangible aids for

children to practice EFT by tapping on specific acupressure points on the hand, upper body and face. Not only can children tap on themselves, but they can also My name is Kelly Zelvis, I have worked in early childhood education for 26 years, I spent 23 years working in a centre-based care service, whilst I loved it, nothing compares to having my own family day care.

I love the smaller setting, the quality relationships and providing an intimate learning program that is play-based, recognizing that children learn best through hands-on exploration and meaningful experiences. It really is a privilege to be a family day care educator and create a beautiful environment that is all about children.

tap on the teddy, leveraging their mirror neurons to enhance emotional selfregulation.

Since introducing the tapping teddy into my family day care program, I've witnessed

firsthand the positive impact it has had on the children. They have eagerly embraced this new tool, using it to manage their emotions effectively and develop a deeper understanding of their feelings. Some parents have witnessed the significant benefits of their children using the tapping teddy and created their own version for their children at home.

Incorporating EFT into our toolkit not only enhances our educational practices but also empowers children with lifelong skills in emotional self-care. I encourage all fellow educators to find out more about how EFT can enhance our approach to nurturing the emotional well-being of the children we serve.

Best known for her feats on the athletics track after representing Australia at the summer Olympics in 2000 and 2004, Jana is a fourtime Commonwealth Champion and two-time World Champion. When continued injuries hampered her athletic career and could have signalled retirement, she swapped the track for the ice,

representing Australia in the women's bobsled team in 2014. She is the first woman to represent Australia in both the Summer and Winter Olympic Games.

Jana's achievements have continued away from the track, completing a Bachelor of Medicine & Surgery, Masters of Reproduction Medicine and pursuing a PhD in Obstetrics, with the hope of progressing her medical career towards becoming an Obstetrician and Gynaecologist. She also serves as an ambassador

## Family Day Care recognised in **Productivity Commission Inquiry** Final Report

In mid-September, the Australian Government released the Productivity Commission's Inquiry into Early Childhood Education and Care's "<u>A path to universal</u> <u>early childhood</u> <u>education and care:</u> <u>final report</u>".

The final report presents the Commission's analysis and assessment of progress towards these policy goals under the current policy, regulatory, funding and governance settings, and presents recommendations to improve upon these settings as a pathway forward to achieve a universal ECEC system.

Significantly, the Commission has recognised and responded to FDCA's longstanding advocacy position around the inequitable Child Care Subsidy hourly fee cap for family day care and the need for a nonstandard hours loading, alongside a number of other key positions, outlined below.

## How did FDCA engage with the Inquiry?

FDCA engaged consistently with the Inquiry, providing submissions, appearing at the Commission's Public Hearing and engaging with the Hon Dr Anne Aly, Minister for Early Childhood Education, and the Department of Education on issues specifically related to the Inquiry, its draft findings and recommendations.

FDCA's submissions reiterated several long-held advocacy positions, while also introducing a number of new concepts, effectively pulling together a broad strategic vision which, through innovation, and program, regulatory and funding reform, the capabilities of family day care could be leveraged to better support many key policy and political objectives of government, and ultimately, better support children and families across Australia.

FDCA emphasised the fact that "for many families, family day care is their only choice, for many more it is their option of choice. A truly universally accessible ECEC system that meets the needs of children and families is unattainable without a robust and growing family day care sector."

## What are the key recommendations for family day care?

A considerable number of recommendations have the potential to impact positively on family day care, depending on how the Government responds, and it should be noted that a number of distinct positions put forward by FDCA in our submissions have been reflected in the final report. In summary (please see full report for complete detail), these include, but are not limited to:


• Recommendation 6.3 - Change the approach taken to indexing the hourly rate cap and review levels of the hourly rate cap for some types of service

- Recommendation 3.4 Develop bespoke traineeship pathways for family day care settings
- Recommendation 5.2 Support universal access in persistently thin markets via an ECEC Development Fund
- Recommendation 5.3 Allow two family day care services to be run in a single venue in regional and remote Australia
- Recommendation 7.3 Review barriers to providing ECEC during non-standard hours


#### What's next?

FDCA will continue to advocate for appropriate consideration and implementation of recommendations that will better support family day care into the future. Thank you to all members who engaged in the various consultation processes across this period to inform the development of our submissions.

It should be noted that due to the scale and proposed phased implementation timeframes, there is clearly a long road ahead, particularly considering there is a Federal Election in 2025. However, it is clear that the important role of family day care has been carefully considered and recognised as a result of our ongoing shared advocacy efforts. We have a clear set of recommendations that are looking to our sector's strengths, and the possibilities for better, more targeted support structures to promote our sector's viability and growth into the future.



Each year, as part of FDCA's Strategic Plan, a variety of Member Initiatives and key projects are planned and undertaken in line with our mission of representing, supporting and promoting the family day care sector in delivering high quality early childhood education and care to more Australian children. e are pleased, in this article, to share with you our 2024-2025 Member Initiatives. These initiatives and projects ensure that FDCA is working towards the goals of our Strategic Plan and will assist our members and the sector in delivering strong learning and developmental outcomes for children.



FDCA's Blueprint for Sector Sustainability ('the Blueprint') will see the development of a defined strategic document designed to bring together a range of work streams, projects, member initiatives and discrete strategies aimed at addressing the decline of family day care educators in the sector.

Represent

While much of FDCA's work is currently looking to address this, the development of an overarching *blueprint* is required as the factors contributing to this are wide ranging and varied, and span multiple departments across local, state and territory and Commonwealth governments, thus a "whole of government" and "whole of sector" approach must be undertaken. The Blueprint will be the result of a "deep dive" on the optimal strategies needed, determine an appropriate prioritisation for the projects/ streams and develop an overarching strategic plan for execution.

Core projects/stream components may include (but are by no means limited to):

- The Family Day Care Capability Trial
- A broadened CALD community engagement strategy
- Exploration of a regional growth strategy innovative solutions to supporting growth in thin/underserved markets
- Monitoring Child Care Subsidy approvals processes and approval numbers
- Representation in the National

ECEC Workforce Strategy's Focus Area 2 outputs

• Post Productivity Commission Inquiry growth initiatives

#### Family Day Care Capability Trial

Announced in June of this year by the Australian Government, FDCA was appointed as the successful tenderer for the two-year Family Day Care Capability Trial ('the Trial').

The Trial will see FDCA partner with a small number of approved services and will comprise several distinct streams of work including testing incentives to promote growth in the family day care sector in pre-determined regional areas of limited supply through investment in recruitment and start-up initiatives. The project streams include:

#### **Educator Recruitment**

As part of the Trial, FDCA will develop a recruitment strategy to attract and recruit new educators to the sector in pre-identified SA2 regional areas in need with limited supply.

This will include a multi-channel recruitment marketing campaign and the administration of a twotiered recruitment incentive funding support.

FDCA will work with participating services and utilise its existing national recruitment strategy structures in executing the recruitment process.

#### **Innovative Model Investigation**

During the Trial, FDCA will meet with representatives from family day care approved services, ECEC sector peak bodies, local and/ or state governments, relevant corporate, not-for-profit and philanthropic organisations and ACECQA to explore alternative models and care types that would benefit regional communities.

Stakeholder engagement and research will identify and drive the exploration of potential placebased but replicable/scalable family day care innovations, which may include:

- Exploring industry funded and/ or community partnerships to increase family day care supply in remote areas
- Explore the expansion of invenue capacity
- Exploring the potential for enhanced approved venues and premises capacity
- Scoping a Traineeship framework for family day care

#### **Digital Attendance Validation**

The development of a "Digital Attendance Verification Tool" will be a key deliverable of the Trial.

FDCA will work in partnership with an external partner to adapt an existing digital identification verification solution to create a tailored platform that will verify children's real time attendance at a family day care session of care i.e. the actual person responsible for their attendance is physically and verifiably at the location where care is to be provided to drop off/pick up children in care.

This element of the Trial will be key to increasing government confidence in Child Care Subsidy payment integrity.

#### Business Systems and Administration Analysis

The Trial will also see FDCA engage an expert third-party subcontractor to conduct a targeted business systems and administration analysis.

This will include exploring digital solutions to identify and close any Family Assistance Law complianceoriented loopholes, develop good/ best practice business process guidance, explore family day care specific enhancements to thirdparty Child Care Subsidy System (CCSS) functionality and scope potential current or future (non CCSS) technology solutions.

This component of the Trial will not only look to improve payment integrity but identify opportunities to reduce administrative burden particularly through technology and business practice guidance.

Through the various streams of the project, we will seek to enhance the evidence base for, and build the confidence in, future government investment to harness the significant potential of family day care in a changing early childhood education and care landscape.

As a "Trial", by necessity this 2-year program will be undertaken with a small number of approved services.

#### Educator Minimum Qualification Strategy

In July 2024, the "actively working towards Certificate III" provision as a minimum qualification for family day care educators was abolished, meaning educators must hold a minimum Certificate III in Early Childhood Education and Care before commencing family day care.

FDCA is aware of the difficulties that this now places on new educators starting their own family day care practice and for approved service in terms of educator recruitment. This initiative will see FDCA investigate innovative approaches to minimise the effect of the removal of this provision.

#### Family Day Care Contractor Model

The strengthening of the family day care contractor model is vital in ensuring the sector's ongoing sustainability. FDCA is committed to providing ongoing improvement in operational practice through research and resources.

Currently, FDCA provides a template educator and service agreement and a suite of contractor model fact sheets, available through the FDCA Member Zone.

FDCA aims to support the sector in the effective and efficient management of, and compliance with, the administrative, business and regulatory requirements of family day care. Throughout 2024, FDCA will review the resources in the context of the recently introduced Fair Work Legislation Amendment (Closing Loopholes



No. 2) Act 2024, specifically the new provisions surrounding Meaning of 'employee' and 'employer' in the Fair Work Act 2009.

The changes came into effect from August 2024.

#### 2025 Family Day Care Election Commitments

In the lead up to the 2025 Federal Election, one of our most important Member Initiatives will be the development of a 2025 Election Commitments document.

Our 2025 Election Commitments document will be developed in consultation with all FDCA members, providing all members will an opportunity to have their say and contribute to FDCA's requests on behalf of the family day care sector.

Following member consultation, FDCA will provide a document to all major Australian political parties outlining the key policy positions of FDCA and associated requests of the family day care sector for the major parties and the incoming Australian Government.

Responses that are received from the major parties will be shared with members to inform them of which policy positions the parties are willing to adopt in the lead up to the Federal Election.



#### FDCA 2025 National Conference

The FDCA National Conference is Australia's premier family day care event and brings together stakeholders from the family day care and early childhood education and care sector, to connect and discuss key issues impacting the sector.

A key event for professional development and networking, the 2025 conference offers all members, educators, coordinators, educational leaders and service managers, an opportunity to connect with both their peers and experts in early childhood education and care. The National Conference will provide delegates the opportunity to explore and embrace the unique strengths of family day care, celebrate the centrality of children across all aspects of our pedagogy and practice, and help us to solidify our collective vision for family day care into the future. Keynote speakers at next year's event include Nathan Wallis, internationally acclaimed New Zealand neuroscience educator, Dr Jana Pittman, former Olympian and World Champion and the first Australian woman to represent Australia in both the Summer and Winter Olympic Games and Anne Hollonds, Australia's National Children's Commissioner.

The conference will be held in Melbourne from 23-25 October 2025 at the Pullman Hotel in Albert Park.



#### **FDCA Learning Hub Review**

As your national peak body, supporting continuous improvement in pedagogical, regulatory and operational practice and creating spaces for the sector to enjoy collaborative learning and networking, are key parts of our mission statement. The FDCA Learning Hub (developed in partnership with Early Child Australia) continues to deliver invaluable resources to members. Members now have access to over 45 contemporary and meaningful professional development modules, all online and available on-demand. The self-paced resources are peer-reviewed by researchers and educators from across Australia, with topic experts translating research into practice and educators sharing examples from their practices.

FDCA will continue to review, refresh and develop learning modules throughout 2024-2025, to best serve the needs of members.

#### Regional Industry Recruitment Program

The direct link between workforce challenges and child care has increased, with many families of workers unable to work due to lack of childcare.

With workforce demands facing heavy industry, state/government programs in regional areas, FDCA have been approached by several private and government lead organisations to support the recruitment and delivery of educators to support those workforces effected.

As a national organisation specialising in family day care recruitment, FDCA is uniquely positioned to support these challenges.

One example (launched in 2023-2024), will facilitate an educator

recruitment pilot for BMA (BHP), to address the shortage of childcare in the regional mining communities in Queensland which impacts BMA employees, this initiative will continue into 2024-2025.

While the pilot with BMA is ongoing, FDCA will work with other industry partners and proactively reach out to prospective partners that are looking to solve childcare challenges within their industries and communities.

This initiative will strive to showcase the unique ability of family day care to meet the child care needs of communities in regional and remotes areas of Australia, making family day care the child care partner of choice for regional industry.

#### Member Engagement Program

Commencing in 2023 the Member Engagement Program has established itself as a staple in FDCA's suite of resources that support members to deliver outstanding early childhood education and care. Providing members with easy to access, relevant information and creating opportunities to connect with external stakeholders and experts, the Member Engagement Program is designed to provide all members with the ability to connect with FDCA via online or face-to-face events

Comprised of the FDCA Online Engagement Series, which has already released 13 episodes, member networking events and service engagement visits, the Member Engagement Program will continue to play a key role in FDCA's ongoing connection with members throughout 2024-2025.

#### Excellence in Family Day Care Awards

Playing a crucial role in generating positive media coverage for the family day care sector, the Excellence in Family Day Care Awards also offer the community the opportunity to recognise those in the sector who continue to deliver exceptional family day care.

Now in its thirteenth year, the 2024 Awards program launched in June 2024 and received over 5000 nominations from across Australia. This demonstrates the amazing work being done by educators, coordinators and services and the impact they have on the community and families they serve.

The Awards culminate with the National Awards Presentation and Gala Dinner, on the 23 November 2024, at the Parkroyal hotel in Parramatta.

#### Family Day Care Advertising Campaign

FDCA will continue to promote family day care through our digital advertising campaigns. These campaigns showcase family day care as the natural choice for early childhood and care for families and as a rewarding and attractive career option for early childhood educators.

The family day care advertising campaign, through the Family Day Care Locator, plays a critical role in generating care leads for educators. During the 2023-2024



period the Locator generated 21,370 enquiries from families looking for child care, that created more than 1,780 leads per month for FDCA members!

The advertising campaigns will utilise Facebook, Instagram and Google Ads to connect with families and potential educators and will run throughout 2024 and 2025. FDCA will also continue to provide marketing support to all members through the FDCA Member Zone via the FDCA Family Day Care Locator (and its associated marketing packages), the Market My Business Hub and FDCA's Family Day Care Photo Library.

#### National Educator Recruitment Program

In 2024-2025, FDCA will continue to support service members increase their educator talent pools and engagement with new applicants wanting to start a family day care. FDCA's dedicated National Educator Recruitment Program will support services to find, evaluate and engage the next wave of family day care educators.

The National Educator Recruitment Program will utilise a national advertising campaign to drive applications through to the FDCA national talent pool as a referral process to service members who need educators. The campaign will include digital advertising via Google Ads, Instagram and Facebook, job board advertisements, media releases, family day care advocacy and direct marketing strategies to promote the family day care educator career path. The program includes an initial applicant screening, validation, and referral of suitable educators to service members, followed up by service satisfaction surveys on the process. The campaign will also build awareness, both within the sector and more broadly, of career opportunities within family day care.

The objective of the National Educator Recruitment Program is to grow applications and educator referrals nationally and in areas of demand and offer a 'one point of contact' for family day care educator applications nationally.

Since its inception in 2021, FDCA's Educator Recruitment Program has helped place over 140 educators with more than 90 family day care services. Eligibility for the program is included as part of a service's FDCA membership.

# Sparking conversations **about culture**

Sinhalese new year celebration for Nilanthi at StarKidz Nilanthi's Family Day Care sparks a conversation about being connected to culture, and a visit to a Buddhist Temple in Melbourne's southeast.

In April, Nilanthi at StarKidz Nilanthi's family Day Care, celebrated Sinhalese New Year at her home with her family day care children. She also invited the coordination unit from her service, Dandenong Community Family Day Care, to come and share this occasion to support children in care to be strong in their culture.

Families and children were so excited to dress up in traditional Sinhalese clothing. Children participated in traditional games and families sent foods like milk rice, kokis and kavum and other traditional sweets. Nilanthi also incorporated customs like



lighting the oil lamp and learning traditional greetings in Sinhalese and introduced Sinhalese music to discuss and incorporate in their play. She displayed photographs and other artifacts from Sri Lanka for children to engage with, which they loved.

The conversations around children being strong in their culture sparked discussions with families about other aspects of their culture, including their Buddhism. The families discussed the challenge of teaching children about why they do what they do at Temple, in an age-appropriate manner, whilst remaining respectful to the community gathering at times of worship.


Nilanthi began thinking about the upcoming Vesak, a Buddhist celebration which the majority of families in her care celebrate. She wanted to support children to learn more about this religious event in a meaningful and age-appropriate way. She carefully planned and reached out to Ven Rasnayakapura Upawarthana, a female monk in the community who has converted her home to a place of worship. Nilanthi discussed with Ven Rasnayakapura, and her service coordinators, her ideas for children to engage in this



space. Ven Rasnayakapura agreed that she could accommodate this for children and was thrilled that Nilanthi was so proactive in supporting children to have this unique experience.

Risk assessments were completed with the support of the coordination unit and families were actively involved in planning the date. Families volunteered to create meals to offer as Dana (offering) for Vesak.

In May Nilanthi and the children met at Ven Rasnayakapura Upawarthana's home. Children were dressed in traditionally white clothes and came with flowers, food and other practical offerings. Ven Rasnayakapura shared with children the key life lessons of Buddhism in an ageappropriate way and then taught the children basic prayer chants. Ven Rasnayakapura and Nilanthi supported the children to make their Dana offerings, explaining step-by-step the process and the special equipment used. The children were fascinated and interested in the surrounds; it was a unique experience. Each child was

given many opportunities to have a hands-on experience throughout this visit. They also participate in a shared meal, back in the family day care environment after the offering to Ven Rasnayakapura, with other community members who were serving at the home.

Parents were very excited to hear children share what they saw and learnt during this experience. Dandenong Community Family Day Care, along with parents, are proud of Nilanthi for thinking outside the box to help children to find meaning in their world, be strong in their culture and explore their cultural identity in a way that challenged their thinking and supported their learning.

## **BUSINESS INSIGHTS** Reducing the risk - burn safety

Did you know that over 76% of burns occur in the home, with almost all of them being unintentional? Most, if not all, unintentional burn injuries are preventable and there are simple steps you can take to reduce the risk of burns within your practice.



Burn injuries are one of the top three causes of unintentional injuries in children under the age of 5 in Australia.

This article will cover the most common types of burns for children and will provide simple safety tips to incorporate into your practice to help start to reduce the risk. The information has been developed using resources by Kidsafe, the Child Accident Prevention Foundation of Australia, who aims to make a safer world for kids.

#### Scalds

Scalds are burns that are caused by hot liquids or steam contacting the skin. Common causes of scalds include hot drinks, such as tea and coffee, as well as bowls of hot noodles or soup. Young children are particularly vulnerable to scalds on their face, hands, arms and chest if they reach for hot liquids within their grasp, often from benches or tables above them.



Scalds are the most common types of burns, accounting for over half of all burn injuries.

Young children can also sustain burns in the mouth and throat through drinking liquids that are too hot. Because babies and young children have thinner skin, their skin burns deeper, quicker and at lower temperatures compared to adults. To reduce the risk of scalds, consider the following safety suggestions:

- Never hold a baby while consuming a hot drink.
- Avoid consuming hot drinks when around children, particularly if they are running and playing. Place all hot beverages out of reach from children, moving cups away from the edge of counters or tables. Where possible, use a cup with a lid to prevent spills.
- During excursions to cafes, ask waiters not to pass hot drinks over children, move hot items away from children's reach and avoid reaching across tables where hot drinks could be accidentally knocked over.
- Test any hot food to ensure it is a safe temperature before serving it to children and drain any hot liquid from noodles.
- Take care when heating baby bottles and avoid using a microwave, as this can create hot spots.
- Check the temperature of the hot water in your home. Setting the water heater to a maximum of 50°C can significantly reduce the severity of burns.
- When supervising mixed age groups, ensure younger children are always kept at a safe distance from cooking areas, and older children are educated on safe practices.

#### **Contact burns**

Contact burns, sustained from touching hot surfaces, are the second most common type of burns within the home. The risk increases in winter with the increased use of heaters and fires. To reduce the risk of contact burns:

- Use safety guards around fireplaces, stoves and heaters.
- Always supervise children around heaters, open fires and candles.
- When in the kitchen, move hot cooking equipment, such as saucepans, to the back of the stove and keep children away from the area.
- Ensure all electrical equipment that heats up, such as kettles, irons and hair straighteners, are unplugged after use and put away or out of reach from children.
- Secure all electrical cords to prevent younger children from pulling them down or playing with them.

#### **Friction burns**

Friction burns are caused when the skin rubs aggressively against any hard or rough surface such as carpets, other floor surfaces or playground surfaces. Injuries caused by friction are usually both an abrasion and a heat burn and often occur from falls, such as from using a bicycle, scooter or skateboard. Friction burns can be quite painful due to the large number of nerve endings which have been exposed to the air.

Prevent friction burns by:

- Encouraging children to wear long sleeves and pants when using a small wheeled device.
- Ensure children use appropriate safety gear, such as knee, wrist and elbow protection.

If the burn contains foreign material, such as dirt, it should be removed by a doctor or other health professional and the wound should be covered to avoid infection.

#### Gold standard of burn first aid

Burn injuries can continue to burn the skin for up to 2-3 hours after the initial incident so it's vital to cool the burn area effectively to prevent further damage. First aid can reduce the severity of the burn even if administered up to 2-3 hours after the burn impact. Treating burns quickly, with the appropriate first aid, can reduce the severity of the injury and shorten the recovery time.



Applying cool running water to the burn for 20 minutes within the first hour of injury will help stop the burning process and begin to cool the burn.

Follow the steps as the 'gold standard' of burns first aid:

- **Prevent** take action to prevent burn and scald injuries to yourself and others.
- **Remove** remove yourself and the child from danger. Carefully remove any clothing, jewellery

or nappies from the burn area unless they are stuck to the skin.

- Cool place the burn under cool running water for twenty minutes.
   Never place ice, oil or butter on the burn.
- **Cover** protect the burn with a clean, non-stick dressing.
- **Seek** seek medical attention if the burn or scald is on the face, hands, lap or feet, is larger than a 20-cent piece or is blistered.



Home remedies such as ice, butter, tomatoes, or toothpaste should never be used as they can cause more damage.



#### No running water? You can still administer burns first aid.

If you are out on an excursion and don't have access to running water, you can administer these three alternatives:

- Bottles of water to cool the burn.
- Applying alternating wet cloths to the burn every 30 seconds (re-wet as needed to keep cool).
- A spray bottle filled with water.

When planning outings, consider the environment you will be visiting and be prepared by packing first aid supplies to respond quickly if a burn injury occurs.

#### Sunburn

We all know how easy it can be to get sunburnt in Australia! Sunburn can occur in less than 15 minutes on a clear summer day during peak UV time, typically between 10am -2pm (or 11am-3pm during daylight saving time). Children have more sensitive skin than adults so it's vital that appropriate clothing and sun protection is used.

To reduce the risk of sunburn:

- Use hats, sunglasses and sunscreen spf50+, even for short periods outdoors.
- Stay in the shade as much as possible and plan activities to avoid sun exposure.
- Keep older children informed about sun safety practices and supervise younger children closely to ensure they are adequately protected.

Sunburn symptoms include reddening of the skin, localised pain and possibly blisters. Skin redness usually appears within 2 to 6 hours of exposure and can continue to develop for the next 24 to 72 hours. Severe sunburn may also cause dizziness, nausea or headaches. Medical assistance should be sought if these symptoms occur.

Suggested first aid for sunburn includes:

- Keeping the affected area out of the sun to avoid further damage.
- Cooling the skin with cold compresses or cool showers.
- Drinking plenty of fluids to avoid dehydration.

#### **Communicating with Parents**

Regularly share burn prevention strategies with parents to ensure safety practices extend beyond your family day care settings. Discuss the importance of supervising children around hot surfaces, ensuring safe temperatures of food and drink and storing household chemicals out of reach. Keeping an open dialogue with parents helps reinforce consistent safety practices across the home and in the care environment.

## SHOULD I SPEND MONEY TO SAVE TAX?

We all want to pay as little tax as possible because the less tax you pay, the more of your hard-earned income you keep.

Since tax is paid on your taxable income or profit from your daycare, the more expenses you can claim to reduce your income, the less tax you will pay.

It might seem logical to spend more on tax-deductible items to minimise your tax. However, buying resources or other items solely to save tax may not always be the smartest choice.

#### EXAMPLE

Caitlin has a family day care and her business earns a taxable profit of \$50,000. She spends an additional \$1,000 on tax-deductible items, and will save approximately \$300 in tax.

While the \$300 tax saving might seem beneficial, if the items Caitlin purchased were unnecessary or did not add value to her business, she effectively loses the remaining \$700.

If you're wondering what purchases you can make to minimise your tax, consider these questions first:

- 1. Is the item or service essential for operating my business, and would I purchase it regardless of its tax deductibility?
- 2. Will the item or service add value to my business and create opportunities to increase my income?

If the answer is yes to either question, then consider the tax implications and how or when to purchase the item in the most taxeffective manner.

Don't shortchange yourself in pursuit of reducing your tax bill.

## Professional boundaries and difficult conversations

... boundaries are actually a relational gift. They act as your personal instruction manual for how to respect and care for you. Dr Rebecca Ray, <u>Empowered boundaries for educators</u>.

Dr Ray continues to tell us that boundaries help take away the guesswork for how people can interact in relationships with you. When we set, communicate and maintain our boundaries, we provide the framework for others to know what to do and what to avoid, to support our psychological safety.

A key relationship for educators is our partnerships with families. For this reason, it is vital to establish professional boundaries that navigate the scope of our role. This might look like guidelines that we use to ethically balance professionalism and empathy in our daily interactions. Boundaries reflect the personal resources that we hold within our metaphorical 'giving tank'. Being aware of what we have available in our 'giving tank' ensures that we balance our partnerships with families and our personal wellbeing.

An example of a professional boundary in practice is managing and responding to conversations with families that may be difficult. Being prepared for a conversation is something we can all do, and it all begins with this simple framework.

#### STOP

Stopping allows us to prioritise wellbeing and can put us in a better



position to assist families. Stopping encourages educators to stop and listen to the family, focus on the current situation and consider the question that is being asked.

Do I feel prepared to have the conversation?

- What are my boundaries around this conversation topic? What options are there for support with maintaining my boundaries?
- When is the right time for this conversation?

#### REFLECT

Reflecting allows us to consider and tailor the appropriate support that will meet the family's specific needs, whilst considering the scope of our role and personal wellbeing.

What do I need to support myself in this conversation?

- How long do I need to prepare for this conversation whilst being responsive to the family?
- What support is within my role? What external support options can I provide in support of the family?

#### ACT

Acting addresses the question after considering previous reflections. When discussing concerns, using a strengths-based approach encourages educators to acknowledge feelings and experiences, offer support, follow up and follow through.

Am I prepared for this conversation?

- What support do I have within my organisation?
- What frameworks and policy documents could offer guidance and support?

Boundaries empower you in your relationships with others by ensuring that you are not giving away your choices. They define what you are comfortable with and what you need from others to support everyone's wellbeing. The Stop, Reflect, Act model is a practical way to support educators in taking the time to consider boundaries when engaging in conversations that may be difficult.

The heart truth is that boundaries are the kindest things that we can offer each other to



## Red Nose champions new Safe Sleep Standards in Australia addressing the risks of inclined sleep

When it comes to baby sleep products like inclined sleepers, rockers, or bassinets, family day care educators and parents alike may find themselves asking important questions: is it safe for a baby to sleep in an inclined position? If a baby falls asleep in this product, will they be safe and comfortable for long periods?

The newly introduced safety and information standards for infant sleep products are now at the forefront of such considerations. These standards aim to ensure that babies sleep in the safest environments possible, a firm and flat, sleep surface with no tilt or incline.

## What is an inclined sleep surface and why is it dangerous?

An inclined sleep surface refers to any sleep product designed with a sloped angle, where the baby's head and upper body are elevated higher than their lower body. This slope can range in degree, but products that incline more than seven degrees are dangerous to a baby by restricting the airway.

#### Why isn't it safe?

When a baby is placed on an inclined surface, their body naturally shifts downward. This can cause the weight of the head to tilt forward, potentially leading to a restricted airway, which can obstruct their breathing and increase the risk of suffocation. Furthermore, the lack of support for their developing muscles means that they are unable to reposition themselves safely if they begin to struggle to breathe. Despite being marketed as sleep aids, these products are not safe and have been linked to several infant deaths.

## Inclined sleepers: a major safety concern

Red Nose has long advocated against the use of inclined baby products for sleep. In fact, Red Nose recently warned about the dangers of inclined sleepers, which are designed with a sloped surface that allows babies to sleep at an angle. Products like these may cause a baby's head to tilt forward, potentially blocking their airway and increasing the risk of suffocation. Despite being marketed as safe, these products have been linked to infant deaths.

That's why Red Nose welcomes the new rules on safety and information standards for infant sleep products. The new standards ensure that all sleep products - such as bassinet, cots, and mattresses - are safe and flat. No infant sleep product should have an inclined surface greater than seven degrees, and no product should include restraint systems, harnesses, or straps.

#### What Does This Mean for Carers?

While it might seem convenient to leave a baby in a car capsule, pusher, or bouncer after they fall asleep, it's important to remember that these are not safe sleep environments and not supported by ACECQA's Sleep and Rest legislation requirements. Babies should always be transferred to a firm, flat, and clear sleep surface as soon as possible.

#### Red Nose's Six Safe Sleep Tips for Carers

- 1. Always place baby on their back to sleep.
- 2. Keep baby's face and head uncovered.
- 3. Keep baby smoke free before and after birth.
- 4. Safe sleeping environment night and day.
- Sleep baby in their own safe sleep space in the same room as their parent or caregiver for at least the first six months.
- 6. Breastfeed baby if possible.

To develop this series, members from across the country reached out to share their unique stories and perspectives with us, outline their journey in the sector and tell us a little bit about what a day in their shoes is like.

#### **Cecile A. Miel** Kentish Family Day Care Darwin, NT

#### How long have you worked in family day care for and where are you located?

I have been an educator at Immaculate Heart Family Day Care NT since 2018. Our service is located in Darwin Northern Territory Australia.

## Can you tell us a little bit about your background in the early childhood sector?

The journey started in 2009 when I arrived in Australia. I worked as a Team leader in different services across Darwin where I was fortunate to meet many experienced educators who influenced and shaped my pedagogy and philosophy as both a person and as an educator. Having a background in teaching sciences and special education overseas, I was able to finish my early childhood qualification in Charles Darwin University years later. If you could provide only one answer to the question – why choose family day care – what would it be?

My own children have also asked me this, "Why chose family day care?" My response is always the same. "My heart is big enough. There is always room for other children. Our home is big enough. There is always room for other people". Today, we are running a mixed program of family day care, Out of School Hours Care and Out of Home Care.

## What has your family day care been up to lately?

Our children have been so busy, especially during the school holidays. Every day was an adventure! We went to the cinemas, bushwalking, fishing and ice skating. The children visited the local library, museum and the wildlife park. They also visited a dental clinic.

We also welcomed many visitors to our day care. The Torres Strait performers Uppai Purri taught our children traditional dances. We also welcomed Uncle Dale from Dingo Cockatoo who facilitated animal encounters and ochre painting. We had didgeridoo music and "Cleansing" with Uncle Les, a traditional artist from Roper River NT. Our children also welcomed our wonderful Kentish CEO and other family day care services for a play group.

### What would you say your family day care is best known for?

Our family day care is known for its holistic approach to education. We are also known for embedding Aboriginal and Torres Strait Islander Cultures in our curriculum. We have been privileged to be invited to the 2022 FDCA National Conference in Hobart, 2023 Early Childhood Australia (ECA) National Conference in Adelaide and the 2024 ECA National Conference in Brisbane.

## What do you like to do when you're not working?

Every day when work is finished, I usually spend the afternoon watering the garden or going for a walk. I call it "nature time". I lock my phone away and don't entertain anymore more calls after hours. I value my weekends as very sacred. That is the time for my family and for my faith.

### What is the best piece of advice you would give to a new educator?

"The road to success is rough, you have to pave it yourself". Welcome each day as it comes. Stay safe and happy. Believe it or not, our children are learning in every direction. The children can "read" us. If you're happy or you're stressed the children can sense that. Our role is very critical in the lives of the children. When done right, family day care is the best scheme there is for early childhood. Make it count.

## What is the biggest change you have seen during your time working in the sector?

The biggest change that I have seen so far is the emphasis on safety and documentation. When I started in 2019, I had to fence my roses and cut all my thorny plants. I could not set up an obstacle course higher than my knee. I advocated for risk associated play, attended professional development in risky play and I have then incorporated that in my curriculum. With the correct documentation, I was able to facilitate activities such as cooking with real fires, building a tree house, having animals in my day care, encounters with water and facilitated excursions with our children. It is a massive and rapidly changing world. Our role as educators is to equip our children with life's tools to be ready and to be resilient.

#### What is the best advice you have received yourself?

"Be a Kentish educator". That was the best advice ever. I established and maintained genuine relationships with Kentish staff and educators. It is great to feel loved and belong. Where I am right now and what future I hold I owe it to my own family and Kentish who accepted me in the first place.

## What has been the highlight of your career so far?

The highlight of my career so far is that I have been able to meet and network with many First Nations Peoples. Just being able to share the land with them is a gift that my family will treasure forever. Being an ECA National Speaker for three consecutive years and being a National finalist in FDCA last year were merely a bonus. GET TO KNOW

## How long has your service been in operation and where are you located?

Nambucca Valley Family Day Care has been operational for over 30 years in the Nambucca Valley and surrounds. We are located on the Mid North Coast of New South Wales.

We currently have Family Day Care Services in the Nambucca Valley, Bellingen Shire, Clarence Valley and Coffs Harbour local government areas.

#### What is your role at the service and your background in the early childhood sector?

The role of our Coordination Unit is to mentor and support our educators with the delivery of inspirational education and care services.

We are very proud of our service, and we see our diverse range of educators as our biggest strength.

Our team has a strong background in early childhood education services from long day care, preschool, playgroups, OSHC, and family day care.

#### If you could provide one answer to the question – why choose family day care? - what would it be?

The community engagement opportunities and meaningful connections with children and families is what makes family day care so unique. Family day care has smaller groups and mixed ages that creates a family atmosphere while offering quality education.

Smaller settings enable children to be truly nurtured and their education developed and shared with their families.

The relationships that are formed between a family day care educators, their families and the wider community is quite profound.

## Could you tell us a bit about what your service has been up to recently?

Our service has had the most amazing year this year. We have gone through Assessment and Rating. To date it has been our most successful Assessment and Rating so far!

Our whole process with the preparation and the actual visit was more than positive and the highlight for us is the growth in confidence that we are seeing from our educators and families who are now sharing the importance of early childhood education and family day care.

Many of our educators have been out and about on excursions which has been an exciting journey for the children in care. For National Simultaneous Storytime, one educator and her children went to the local Botanical Gardens to read the chosen book. Whilst on excursion they were treated with a visit from a bowerbird nesting in the gardens.

Other excursions have embraced walking to local playgroups including Sprinkle and Play which is a sensory play playgroup. The educators walked through town and even visited the mechanics on the way home. Family feedback about our excursions has been very

positive and we are working towards engaging more community input and excursions.

## What would you say your service is known for?

Nambucca Valley Family Day Care is known for being a supportive service that is passionate about promoting their diverse range of educators. They work beside their educators to encourage and assist in the delivery of quality education and care for families, children and the community.

The team at Nambucca Valley Family Day Care work closely and support their qualified homebased Educators to ensure they provide high quality, home-based, personal and flexible care for their enrolled children.

## How does your team like to have fun outside of work?

Our team is very family orientated. We spend our weekends with family and friends embracing children's sports, family gatherings, fishing, signing in the local choir, gardening and going to the gym.



I found this book to have beautiful illustrations and a great story about friendship and finding the best in the simplest things. My little listeners were not as engaged with the book as they usually are, they were ages 3 and under. It was a little long so I think this story would best suit the older preschool children in services.

Kindness Rocks was definitely the favourite for both the children and myself. From front to back cover the pages are filled with bright coloured pictures and rhyming sentences to engage even the most restless little listener. The story itself was a fantastic way to show the children different things they can do to be a good friend. The children enjoyed the activity of finding "Sprout" throughout the book. This book provoked some thought and led to further discussions on the topic of friendship, particularly amongst my 3-5 year-olds. I highly recommend!
