

Feedback from annual member survey

Every year, MiEnergy Cooperative conducts a member satisfaction survey to evaluate our performance and gather member insights on programs, services or electric rate options under consideration. This fall, 5,085 members were randomly selected to participate in an online survey conducted independently by a third-party. We received valuable responses, and we sincerely thank all members who took the time to provide their feedback.

SURVEY HIGHLIGHTS

The survey results show an impressive level of satisfaction among members, demonstrating consistent improvement dating back to 2017. Here are the key findings:

- 54% of respondents rated MiEnergy a perfect score of "10" on a 1-10 scale for satisfaction. 29% gave an 8 or 9 rating, highlighting excellent overall performance.
- MiEnergy's overall American Customer Satisfaction Index (ACSI) score remains higher than our neighboring investor-owned utilities (IOUs).
- Members were highly supportive of our optional Time-Of-Use rate when paired with meaningful incentives. Approximately 33% expressed interest in this rate, while 40% requested more information.
- Two-thirds of members said they would be interested in a peak demand program in exchange for a bill credit. Almost half of members surveyed are interested in a standby generator program managed by MiEnergy or coordinated with area electricians. There is also interest in the co-op offering programs for residential energy audits and smart thermostats.

KEY PERFORMANCE ATTRIBUTES

Of the 18 performance attributes measured in the survey, MiEnergy achieved scores of 4 or above (on a 5-point scale) for all but one. The top 5 rated attributes in order:

- 1. Friendly and courteous employees
- 2. Highly-trained professional employees
- 3. Community support

These outstanding ratings reflect

the dedication of our employees and our commitment to our membership. The lowest rated attribute was related to electric rates, which aligns with national trends. Even so, MiEnergy's value for the money rating was 4.24 on a 5-point scale.

OTHER INSIGHTS

- Seven in ten members have had to report a power outage, with most calling us to report it. A growing number are using SmartHub to report outages, especially outside regular business hours, and expressed high satisfaction with its convenience.
- Members said these top factors for the board and management to focus on are keeping electric rates affordable and maintaining reliable electric service. The factors showed a significant priority over sustainability, energy management programs and retiring capital credits.
- Member loyalty remains strong, with MiEnergy scoring an 8.46 on a ten-point scale—surpassing national cooperative norms. Loyalty is tied to members' feeling:
 - Proud to be associated with MiEnergy
 - Confident in their relationship with MiEnergy
 - MiEnergy is one of the best organizations of its kind

ADDITIONAL FEEDBACK

Approximately one-third of survey respondents shared additional comments, 75% of which praised MiEnergy's electric service. Topics of renewable energy and climate change saw minimal comments compared to previous years.

Members questioned our basic service charges, comparing them to Xcel Energy and Alliant Energy, neighboring investor-owned utilities (IOUs.) Both have lower basic service charges than MiEnergy, but provide electric service in cities, suburbs and communities with tremendously greater density. MiEnergy averages less than 4 members per mile of line while IOUs average 30 to 40 for recovering those fixed costs. Despite the higher basic service charge, in many cases MiEnergy's overall bill is lower than the IOUs for the average member when including the energy rate because of the added delivery and transmission charges that they pancake on to the kilowatt-hour charges.

LOOKING AHEAD

The survey continues to serve as a valuable tool for enhancing our operations. Past surveys strongly influenced the addition of outage texting, SmartHub and our electric vehicle subscription rate program.

Protect your HVAC system and vents from snow and ice

Winter is fast approaching, and it's important

to protect your HVAC (heating, ventilation, and air conditioning) from cold temperatures as well as snow and ice buildup. HVAC units are built to withstand some snow and ice, but they also require good air flow to function and will not work properly and can be damaged if operated with snow buildup.

- Be sure to keep at least 18 inches of clearance around each unit. This may require you to shovel or dust snow away from the unit. But do so with extreme caution so you don't hit or touch the condenser.
- Be sure that gutters and pipes are not forcing water onto a heater or air conditioning unit. You don't want an icicle to fall and possibly damage the unit.
- Continue to clean and change your furnace filters even in wintertime. It is recommended cleaning or replacing furnace filters each month during the heating season.
- Check and clean air vents throughout your home. The buildup of dust and dirt within your home can cause ventilation blockages and inefficient airflow.
- Check your furnace air intake pipes or vents. A vent that is buried in snow is starving your furnace for the air it needs for combustion.

Now is also a good time to start researching options for an energy efficient air-source heat pump or geothermal heat pump if plans are in your future to replace your HVAC system.

Water heater woes

We've all gotten used to having reliable hot water in our homes. Nobody wants to get caught off guard with an unexpected cold shower or failed water heater.

Emergency replacement of a water heater can add unnecessary cost, not to mention inconvenience. Here are some signs that your storage water heater might be approaching the end of its life:

 The typical lifespan of a storage water heater is 10 to 15 years, according to the U.S. Department of Energy. If your water heater is older than that, plan to replace it soon. Don't have records of when it was installed? Find the serial number on the water heater's sticker or metal plate and look it up online or call the manufacturer to find

- Sediment or water on the floor or at the bottom of the water heater could mean its days are numbered. Sediment can be a sign of corrosion, which leads to a leak or failure.
- Seeing rusty or discolored water when you turn on your faucets can be a sign the tank is rusting inside. If water is not as hot as it used to be, it could be a sign of a failing electric element or a gas burner.
- · Odd noises could indicate an issue with the components. If you're hearing unusual noises from your water heater, schedule a checkup with a plumber.
- A professional plumber may be able




to replace failing components. If you are having issues with the tank itself, it's likely time for a new unit.

- If you're in the market for a new water heater, a heat pump water heater might be a good fit for your home. These systems are two to three times more energy efficient than conventional electric-powered tank water heaters, according to the DOE. A federal tax credit is available until Dec. 31. You can claim 30% of the project cost, up to a maximum of \$2,000, for the installation of an Energy Star heat pump water heater. If your water heater is past its useful life or showing any signs of failure, consider investing in a new one before the end of the year. Check with MiEnergy for rebates on electric water heaters purchased from the co-op and heat pump water heaters purchased elsewhere.
- Even if your water heater is in great shape, you can save at home by lowering your hot water use. Some easy ways to do this are washing laundry in cold water and installing high-performance aerators on faucets and shower heads to reduce the amount of hot water you use.

Knowing the signs of water heater failure can save you from home damage and offer opportunities to explore options for more efficient equipment to lower your electric use.

Not only are they learning how to sew, quilt and perfect their seams and stitches by avid seamstresses who have spent countless hours with a needle and thread throughout their lifetimes, but at the same time they are gaining knowledge about the power of doing good for others. And with a little bit of patience and goodwill, a handful of kids are now well equipped to help those who might just need

a little bit of comfort and warmth. That kindness extends with many hands working on this worthwhile community project, and our cooperative is proud to partner with them.

MiEnergy, in collaboration with Dairyland Power Cooperative, presented \$2,000 to Quilters Therapy on November 6, demonstrating their ongoing commitment to supporting the communities they serve through the Cooperative Contributions Program. Each cooperative donated \$1,000. Dairyland Power Cooperative is

The donation supports expanding their quilting knowledge to a junior quilters group through

the Fillmore County Community Comfort Project. The junior quilters, ranging in age from 6 to 14, crafted the project to supply blankets to the Fillmore County Sheriff's Office first responders. Their initiative aims to offer comfort to those facing difficult circumstances. Deputies will have the blankets readily available to provide to children or adults during emergency responses.

community. They meet on the first Monday of the month at Henrytown Lutheran Church. Currently, they have 27 adults, plus 9 juniors for a total of 36 members. The adults started a youth outreach campaign last year teaching school-age kids sewing and quilting skills. The group is excited to help the next generation learn and develop their skills.

Every year in September, they hold their annual quilt show during Mabel-Hesper Steam Engine Days. In 2024, they presented 25 quilts for local veterans and routinely keep 10 quilts on hand in case of benefit auctions or tragedies like fires.

OPERATION ROUND UP FUNDS IN 2024

In 2024, the group used a \$500 grant from MiEnergy's Operation Round Up program toward expenses for their donation of 23 quilts for a project called Shop with a Cop, benefiting Fillmore County third graders. Each year,

"We are grateful for the generous financial support for the community projects," said Roxi Thompson, Quilters Therapy treasurer. "We used the funds to purchase soft, warm, cozy fleece to stitch up double layered twin-size blankets that fold into an attached pillowcase."

The blankets are packed into plastic zipper bags. Deputies and first responders will carry the blankets with them and provide the blankets whenever a little comfort is needed.

"Our Junior Quilters, aged 6 to 14 years old, assisted with sewing the blankets. This is a challenging fabric because it is a bit stretchy. Handling the large volume of fabric is also a new experience," Thompson explained.

Purchasing Appliances and Electronics: Best Times to Buy

Product Type	Best Time to Buy for Discounts
Refrigerators and Freezers	Late winter to early spring (March/April); New models arrive in spring, and older models are discounted; Holiday sales (Memorial Day, Fourth of July, Labor Day).
Washers/Dryers, Dishwashers, Ovens and Ranges	September and October when new models are released and older models are discounted; Holiday sales (Labor Day, Black Friday, Presidents' Day, Memorial Day); End-of-year clearance.
Large Home Electronics (TVs, home theater)	Holiday sales (Black Friday and Cyber Monday); Amazon Prime Days; Late fall/early winter; Other promos, like Super Bowl sales for televisions.
Smart Assistants and Other Smart Devices	Holiday sales (Black Friday, Cyber Monday); Other sales events, like Amazon Prime Days.
Air Conditioners, Heaters and Other Seasonal Appliances	Off season (purchase AC units in fall or winter, heaters in summer); Retailers offer bigger discounts when demand is low.

Additional Purchasing Tips:

- When possible, bundle major appliances for significant savings.
- Be on the lookout. When new models arrive, older models drop in price.
- Retailers typically clear out inventory at the end of the year, which means big discounts.
- Local retailers typically try to meet end-of-month/end-of-quarter sale quotas, which could mean flexible prices and/or negotiating.





Energy Efficiency Tip of the Month

To maximize your fireplace's efficiency, always keep the damper closed when the fireplace is not in use. An open damper is like an open window, allowing warm indoor air to escape and cold air to enter. Consider installing a fireplace insert, which improves heat output by circulating warm air into the room rather than letting it escape up the chimney. Also, burn only seasoned hardwood to ensure a hotter, cleaner burn. Regularly clean and inspect your chimney to maintain safe and efficient operation.

IOWA MEMBER NOTICE ON SALES TAX EXEMPTION

There is a tax exemption that could save you money if your business is agricultural, manufacturing or processing related.

Since January 1, 2006, residential customers are no longer subject to state sales tax. State sales tax rates are applicable for non-residential customers, unless a sales tax exemption certificate is filed with the cooperative. If you use electricity for processing/agriculture, you may be eligible to file a sales tax exemption certificate for the portion of your electric use that qualifies.

The certificate may be valid for up to three years and you can also file for refunds for past years, up to a maximum of three years.

You are not required to have exempt usage metered separately, but are required to calculate the percentage of exempt and non-exempt usage.
