


## INTRODUCTION TO OUR UNIVERSITY

**Pázmány Péter Catholic University** (PPKE) is an accredited, state-recognized higher education institution in Budapest, Hungary, run by the Catholic Church and governed by the Hungarian Catholic Bishops' Conference.

The foundation of our institution in Nagyszombat in 1635 and its re-foundation in 1992 are the cornerstones of **Hungary's oldest continuously operating university**. With its diverse training system, PPKE serves both the transmission of traditional knowledge and values necessary for the development of the entire human personality, as well as the formation of the information society and its adaptation to human fulfillment.

The spirit of our university is fundamentally determined by its **Catholic affiliation** and the resulting **human and community values**. Respect for each other, building a professional and friendly community across generations, as well as paying attention to each other and helping each other are of fundamental importance to us. Knowledge is transferred in a people-oriented environment, always taking into account the capabilities, skills and needs of our students. We pay particular attention to the importance of high-quality science and education. 

## FACULTY OF THEOLOGY

The Faculty of Theology, the oldest faculty of our University, has been continuously engaged in theological education for nearly 400 years since its founding in Nagyszombat, in 1635. Despite facing significant challenges at times, it has upheld the tradition of theological education under the name of Pázmány.

In 1950, the Faculty of Theology was separated from the other faculties of the Royal Hungarian Pázmány Péter University and operated for several decades as the Roman Catholic Central Academy of Theology in the building of the former Pauline monastery, now home to the Central Seminary. In 1998, as part of the newly restructured Pázmány Péter Catholic University, the Faculty moved into its current location on Veres Páldné Street. Today, its lecture halls are equipped with state-of-the-art IT technology.

The Faculty of Theology offers both full-time and correspondence programs, officially recognized by both the Catholic Church and the Hungarian state. Degree programs taught in Hungarian include Theology, Religious Education, Community Organization, Catechetical-Pastoral Associate training, as well as advanced studies in faith and morals. Theology can also be studied in combination with other liberal arts teaching degrees.

The Faculty's Doctoral School, operated jointly with the Postgraduate Institute of Canon Law, offers state-recognized doctoral degrees in both Theology and Canon Law. The faculty library has expanded significantly in recent decades and now includes access to an integrated library system and various academic databases.

Each academic year, the Faculty hosts several thematic conferences, featuring presentations by both national and international experts. Edited proceedings are published in the *Varia Theologica* series and other scholarly volumes. The Faculty's Hungarian-language academic journal is *Theology*, while faculty members also contribute theological studies in foreign languages to the journal *Folia Theologica et Canonica*.

The Faculty maintains strong international partnerships, allowing both students and staff to participate in research and exchange programs, primarily through the Erasmus program.



## FACULTY OF THEOLOGY

### I welcome you on behalf of the community of the Faculty of Theology!

In the mid-fourth century, Christians were engaged in serious discussions about which books should be entrusted to young minds. At that time, Christian literature offered little in the way of poetry, so those wishing to master classical Greek, had to turn to works like those of Homer and Hesiod. However, the characters portrayed in these texts, by their actions, often could not be held up as role models for young Christians.

Recognizing this concern, Saint Basil the Great addressed the issue in his work *Exhortation to the Young*. Writing to his nephews, he offered the following advice: „Take books as an example from the bees. Bees do not indiscriminately visit every flower, but rather extract only what is useful for their work. Similarly, we should draw from literature only what aligns with truth and serves our moral development, and remain cautious of the rest.”

Today, in an era defined by the overwhelming abundance of information and digital content, young Christians face similar challenges. Can we trust the flood of information surrounding us? Are the figures celebrated in today's narratives truly worthy of imitation?

At the Faculty of Theology, we strive to equip our students with the intellectual and spiritual tools to answer life's most profound questions with authenticity and clarity. The philosophical and theological disciplines taught in our Faculty can prepare our students to become acquainted with Scripture and the Sacred Tradition of the Church at the beginning of the third millennium, so that they can enrich the Catholic Church with their work as a priest, monk or religious teacher.

We also warmly welcome those who do not choose theology as their life's vocation, but who are captivated by the Truth, Goodness and Beauty found in the world of nature and man, in the richness of the arts, for whom it is already clear that a deeper knowledge of the culture that the Church has cultivated for two thousand years is essential to understanding our European civilisation.

## Martyrs of the Faculty of Theology

Pope John Paul II called the 20th century the “century of martyrs” because totalitarian dictatorships claimed as many victims among the priests, monks, and followers of Christian Churches as the persecution of the Church in the early history of Christianity. To ensure that the memory of the martyrs of more recent persecutions of the Church is not forgotten, the Catholic Church has made them role models through beatification. The Catholic Church has beatified those who bore heroic witness to Christ through their lives and their perseverance in the faith, setting them as examples for Christians today.


Seven former students at our university's Faculty of Theology have been beatified so far, all of whom were victims of the communist dictatorship in the 1950s. Since the Faculty of Theology has been a multi-ethnic community embracing several Catholic rites since its foundation, our martyrs include Romanians, Germans, and Ruthenians alongside Hungarians; in addition to Roman Catholics, there are also Greek Catholics, and one of them even had Armenian Catholic roots in his family.

Even before World War I, Romanian Greek Catholic bishops studied here, who were later imprisoned after the Romanian People's Republic, which had fallen under the sphere of influence of the Soviet Union, banned the Uniate Church in 1948. Bishops Valeriu Traian Frențiu (†1952) of Oradea, Ioan Bălan (†1959) of Lugoj, and Alexandru Rusu (†1963) of Maramureș resisted State pressure, refusing to convert to Orthodoxy and urging their priests and followers to do the same. The Greek Catholic Church was also banned in the Czechoslovak People's Republic in 1950, and Bishop Pavel Petro Gojdics of Eperjes was convicted in a show trial as a “Vatican spy” (†1960). In Romania, the leaders of the Latin Rite dioceses were also deprived of their freedom after 1948; Bishop János Scheffler of Satu Mare preferred to serve a prison sentence rather than organize a “national Church” subordinate to the State (†1952). The Holy See then sought to maintain the hierarchy by ordaining younger secret bishops, but they were soon arrested as well; thus, Szilárd Bogdánffy of Nagyvárad died in prison (†1953). Soviet-style persecution of the Church also spread to the Hungarian People's Republic, where the Churches were also hit by reprisals after the 1956 revolution; it was then that a young priest, János Brenner (†1957), fell victim to an assassination organized by the political police.

In addition to the above, the beatification process is underway for Ervin Gábor, who was also a member of the Faculty of Theology and fell victim to Nazism in Budapest (†1944).









The former Vitéz János Faculty located in Esztergom was integrated into our Faculty as the Vitéz János Centre for Teacher Training in 2013. At the Faculty, there are Bachelor, Master and PhD programs in the fields of humanities, social sciences and economics, ranging from Hungarian and several foreign languages to history, art history, philosophy, aesthetics, psychology, sociology, international studies and more. # PROGRAMS AND FOCUS AREAS

Our work is carried out in a spirit of community: the university is a fellowship of students and lecturers who work together harmoniously. Through collective reflection, we aim to identify and offer solutions to the serious contemporary issues that threaten human dignity. Pázmány professors are influential legal scholars and passionate educators. We aspire to nurture intellectuals who are committed to serving both individuals and broader communities, while also developing their own talents to the fullest. We explore and teach how the legal system can support individuals and communities in cultivating their own unique set of values.

## **Law (Integrated Single-Cycle Programme) – held in Hungarian**

This five-year, integrated, university-level programme leads to a Master of Arts (MA) degree in Law. It provides comprehensive preparation for the legal profession, with its roots in ancient European legal traditions, particularly those of the Roman Empire. A law degree provides a broad education in the humanities that can be applied across a wide range of professional fields.

Beyond traditional legal careers, such as those of judges, prosecutors, or attorneys, this qualification opens doors to diverse professional paths with promising opportunities for advancement and personal growth. Graduates may, for example, lead their business ventures, work in the media, specialize in data protection in either the public or private sector, or serve in diplomatic roles, for example.

## **BA in Judicial Administration – held in Hungarian**

This six-semester undergraduate programme provides professional training in judicial organization. Judicial administrators are practical professionals who primarily support the decision-making processes within the justice system. Their responsibilities include assisting with the preparation and implementation of judicial decisions.

Most graduates pursue careers as court clerks, judicial or enforcement administrators, or court officers. Others find employment in various areas of public administration, including social services, land and property registry, or tax administration.

## Master of Business Administration (MBA) – held in Hungarian

The MBA is a postgraduate programme designed to prepare students for leadership roles in business. The first MBA programme was established at Harvard University in 1908. Today, MBA programs target individuals who already hold a bachelor's degree and have relevant work experience, but wish to deepen their business knowledge and leadership skills.

This qualification primarily provides access to a wide range of business management and executive positions.

## Relationship with professional associations

Our training offers numerous opportunities, promising career paths and personal development in countless areas, particularly in the fields of 'traditional' legal careers, such as judge, prosecutor, lawyer, notary public, civil servant, or legal advisor.

The Faculty has an extensive network of contacts in the legal community. We have numerous professional and career agreements with law firms, government agencies, and companies. Our staff and lecturers also have close ties with professional legal associations and institutions.

We have contracts with hundreds of partners participating in our legal internship programs, including courts, public prosecutors' offices, government agencies, law firms, companies, and ministries. Our Deák Ferenc School for Postgraduate Studies offers several specialized courses that are specifically related to the different legal vocations, where our instructors pass on their personal professional experience to the students.

## Pázmány specific value

Our goal is to train lawyers who are well-versed in the legal profession, who constantly seek truth and justice, serving their community and the created environment.

We support our students not only in becoming excellent professionals who meet the needs of modern society, but also in becoming people with a solid ethical framework who provide sound solutions to the moral dilemmas arising during their professional careers.

Our graduates set noble goals: to promote justice and the common good, to lift up the disadvantaged, to protect the vulnerable and the weak, and to preserve the peaceful order of society.

# PROGRAMS AND FOCUS AREAS

## What makes us stand out?

The Faculty of Law is an indispensable and internationally recognized faculty in domestic legal education and research. Instructors of professional renown in various fields of study train students, not only in classroom settings, but also in research workshops and moot court preparation sessions.

The Faculty places a strong emphasis on talent management and mentoring programs. New students receive personalized assistance and support from the very first moment from the Study Department, mentor teachers, and the student organization specializing in this area, the community of the so-called Tutors. In this way, the Faculty helps students and incoming Erasmus students to settle into their university life, supports them in developing their talents to the fullest, and helps them to excell in both domestic and international moot courts and contests.

As a Catholic law faculty in Hungary, we feature canon law as a compulsory subject in our training program, with a separate institute of Canon Law Studies. In addition to the Department of Environmental Law and Competition Law, there is also a research group dealing with creation care, which does outstanding work in preparing future lawyers for challenges faced in the field of sustainability and equity.

We are also versatile in the field of continuing education. We offer nearly 20 specialized postgraduate programs, including Digital Transformation Lawyer, which is very popular among students.



## CANON LAW POSTGRADUATE INSTITUTE

Canon Law, in its strict sense, refers to the internal legal system of the Catholic Church, designed to ensure order and proper governance within the ecclesial community.

The Canon Law Postgraduate Institute currently offers both a Master's program (MA) in Catholic Canon Law and a doctoral programme in Canon Law, the latter being part of the Pázmány Péter Catholic University's Doctoral School of Theology. Admission to the Institute is open to those who hold a BA or MA degree in Catholic theology or a degree in law. Upon completion of studies, students may earn the academic degrees of Bachelor of Canon Law (MA), Licentiate in Canon Law, and Doctorate in Canon Law (PhD). For applicants who hold different academic qualifications or are still engaged in higher education, the Institute provides a part-time program in canon law.

The Institute also actively supports the professional development of outstanding students by offering access to international academic and professional networks in the field of canon law.

The doctoral degrees in canon law awarded by the Institute in the name of the Pope are internationally recognised within the Catholic Church, in addition to the recognition by the Hungarian state.

The Jedlik Laboratories at the Faculty of Information Technology and Bionics conduct world-class research at the interface of biology, computer science, mathematics, physics, and info-bionics, with particular strengths in bioinformatics, electrical engineering, artificial intelligence, and machine learning. Thirty-two research groups collaborate closely, fostering a strongly interdisciplinary environment that ensures the Faculty remains at the forefront of technological development.

Research encompasses a wide range of areas, from biology-inspired and neuromorphic models, systems biology, and molecular dynamics to advanced sensor technologies, robotics, telepresence, human language technologies, and integrated hardware-software solutions. A special focus is placed on bionics research for the Cybathlon, the international “Olympics of Bionics,” where teams develop and apply assistive technologies for people with disabilities.

Innovation is a core pillar of the Faculty’s mission. 

## EDUCATION AT THE FACULTY OF INFORMATION TECHNOLOGY AND BIONICS

At Pázmány ITK, education and research form a seamless whole. The Faculty offers a complete academic pathway from undergraduate to doctoral level, preparing students for a world where technology and life sciences increasingly intertwine. Our Bachelor's programs, taught primarily in Hungarian, provide a strong foundation in IT and bionics, with several courses offered in English from the fifth semester to foster international readiness.

Building on this foundation, our Master's programs – all taught entirely in English – represent the cutting edge of interdisciplinary education. Students can choose from: Bioinformatics, Computer Science Engineering, Info-Bionics Engineering, Medical Biotechnology, Quantum Engineering, and the prestigious Erasmus Mundus Joint Master's Degree in Image Processing and Computer Vision (IPCV). The IPCV program is offered in collaboration with Université de Bordeaux and Universidad Autónoma de Madrid), focusing on AI-driven image analysis and computer vision.

Students at ITK work closely with leading researchers in an inspiring academic environment, equipped with world-class laboratories and advanced research infrastructure. The Faculty's human-centered approach ensures personal mentorship and genuine academic community, where students are regarded as young colleagues contributing to ongoing innovation.

Our Doctoral School offers PhD programs in Information Science, Electrical Engineering Sciences, and Biological Sciences. Doctoral candidates join vibrant, internationally connected research groups engaged in high-impact projects across fields such as artificial intelligence, neurotechnology, medical imaging, and sensor systems. The Faculty's "Excellent Research Site" distinction, awarded by the Hungarian Academy of Sciences, underscores the quality and impact of its research ecosystem.

# RESEARCH

## Faculty of Theology

### Pentateuch Research Programme

The research project in the Department of Old Testament Scripture studies examines the problem of the origins of the Mosaic books and the so-called Pentateuchal question, with a special emphasis on the analysis of biblical prehistory and the patriarchal stories.

### Church History Research Group

The research group is primarily engaged in the exploration and publication of the as yet little researched source and institutional history of the medieval and early modern Hungarian church history.



## Faculty of Humanities and Social Sciences

There are more than thirty research groups at the Faculty of Humanities and Social Sciences of Pázmány Péter Catholic University, fostering research interests across various fields within the humanities and social sciences. These include philosophy, literature, language, history, archaeology, psychology, communication and media studies, art history, care policy, sociology, and pedagogy. Our research spans from traditional archaeological, literary, and ecclesiastical historical studies to more interdisciplinary approaches, encompassing media psychology, experimental linguistics, artificial intelligence, and numerous other areas.

The Faculty's notable research groups include the Baroque Literature and Spirituality Research Group, the Vilmos Fraknói Vatican Historical Research Group, and the Adolescent Development Research Group, which are all part of the HUN-REN Hungarian Research Network. The Bosphorus Research Group conducts interdisciplinary research into the recent past of the Balkans, the Mediterranean, and Turkey, also focusing on current political, economic, and social processes, as well as the prospects of the regions. Less traditional is the interdisciplinary research group on popular culture and fantasy in English-speaking countries, which aims to examine English-language fantasy literature and visual culture, as well as popular culture.



# RESEARCH

## Faculty of Law and Political Sciences

Research is conducted in a variety of individual and group formats. The most important ones take the form of research teams or research centres. The following research centres are currently active in the faculty:

**Competition Law Research Centre**

**István Ereky Public Law Research Center**

The *Pope Saint John Paul II Research Centre* was established in 2020. The aim of the Research Centre is to contribute to the research work of PPKE in the search for truth, the preservation of knowledge and its transfer to the benefit of society, complementing the research carried out in the faculties of PPKE in a subsidiary manner. In its research, it seeks to integrate knowledge, to dialogue between faith and reason, to take into account the ethical aspects of the subject of research and to present its theological perspectives. The Centre is pursuing these objectives through the production of scientific publications, the translation of scientific textbooks, the organization of conferences and the dissemination of scientific knowledge. The Centre operates under the direct authority of the Rector.



## Research Institute for the Integrity of Creation

The Research Institute for the Integrity of Creation started its work in January 2022, at the The Pope Saint John Paul II Research Centre of Pázmány Péter Catholic University. In the early 1990s, the leadership of Pázmány Péter Catholic University recognized that the environmental crisis is both a technological and a social challenge, which can only be met in a new, holistic, creative, and innovative way. Therefore, basic environmental literacy is essential for intellectuals and especially important for the legally qualified ones. It is known that the unfolding sustainability crisis has not escaped the attention of the Holy See, and guidelines provided by the church regarding the issue have been published since the 1980ies.

For the above reasons, in 1995, the Faculty of Law and Political Sciences of Pázmány Péter Catholic University was the first in Hungary to establish a department of environmental law. The Research Institute for the Integrity of Creation represents a further step forward in this process for the university and for Hungarian academia.

So much so, because the protection of creation is more than environmental protection with a religious approach. At its core is the preservation of the world created by God, and therefore, in addition to the ecological approach, it also involves many other disciplines such as philosophy, sociology, law, psychology, economics, education, media studies, communication, and health.




# SCHOLARSHIPS

Pázmány Péter Catholic University nurtures an extended network of international relationships and partnerships in Europe and all around the world. This network guarantees diverse options in partnerships, be it mobility, research, joint education, projects or other activities.

## Erasmus+ KA131

PPKE has been for a long time active in the Erasmus KA131 Program, funded by the European Union, which provides mobility opportunities between program countries for students, teachers and staff of higher education institutions. Pázmány Péter Catholic University has an ever-growing number of bilateral agreements with universities from the EU and universities from third countries associated to the Programme within the framework of Erasmus KA131, thanks to which a large number of outgoing and incoming mobility takes place every academic year. Our biggest partners of exchange are French, German, Italian, Polish, Spanish and Portuguese universities. PPKE organizes Blended Intensive Programs every year in different thematic fields for which students and staff from partner universities are warmly welcome.



## Erasmus+ KA171

Starting from 2016, PPKE has established close ties with several universities worldwide within the framework of Erasmus+ International Credit Mobility (Erasmus KA171) programme, which gives the opportunity for incoming and outgoing student, teacher and staff mobilities in the relations of PPKE and our partner countries from outside of Europe. We have long-time relations with partner universities from Iraq, Syria, Jordan and Israel, strong relations with partners from Armenia, as well as from Indonesia, Kenya, Georgia, and Ukraine.



## CEEPUS

The aim of the CEEPUS (Central European Exchange Programme for University Studies) is to enable student and teacher mobility, organize special courses and student excursions between partner institutions cooperating in the field of higher education, and support the development of long-term professional cooperation in the region, thereby promoting and strengthening the strategic role of Central Europe. Within the framework of the program, students and faculty have the opportunity to carry out mobilities in higher education institutions in CEEPUS countries (Albania, Austria, Bosnia and Herzegovina, Bulgaria, Czech Republic, North Macedonia, Croatia, Kosovo, Poland, Hungary, Moldova, Montenegro, Romania, Serbia, Slovakia and Slovenia).

## Erasmus Mundus Joint Masters

Our Faculty of Information Technology and Bionics is a proud partner in the two-year Erasmus Mundus Joint Master's Programme in Artificial Intelligence for Image Processing and Computer Vision (IPCVai). This prestigious international programme brings together three leading European universities at the forefront of image analysis and computer vision: Universidad Autónoma de Madrid (Spain), Université de Bordeaux (France), and Pázmány Péter Catholic University (Hungary).

The IPCVai Masters program offers a truly interdisciplinary curriculum, combining electrical engineering, applied mathematics, computer science, and computer engineering with cutting-edge expertise in artificial intelligence and neural network models. The programme equips students with the theoretical foundations and practical skills needed to design next-generation vision systems - from advanced image analysis tools to intelligent perception technologies - preparing them for high-impact careers in research, industry, and innovation across Europe and beyond.

## **Stipendium Hungaricum Scholarship Programme (SH)**


Founded in 2013, the Stipendium Hungaricum is the Hungarian Government's most prestigious higher education scholarship programme, offering a wide range of degree programs for high-achieving international students.

It is available for students from five continents and from over 90 partner countries, attracting tens of thousands of international students each year. The program is based on bilateral educational cooperation agreements signed between the Ministries responsible for education in the sending countries and Hungary.

The scholarship covers tuition-free education, a monthly stipend, dormitory accommodation or housing allowance, free state-funded healthcare, complementary private health insurance, free visa and residence permit administration for the scholarship holders. Scholarship holders are guaranteed a student visa and then a residence permit for study purposes for the entire duration of their studies.

It is available for Bachelor, Master, Undivided, Doctoral and Non-degree Programs.

## Scholarship Programme for Christian Young People (SCYP)




## Uniservitate Network


