Do you have the necessary steps in place to adapt? One great tool for many businesses—especially those with multiple owners—is **buy/sell agreement life insurance**.

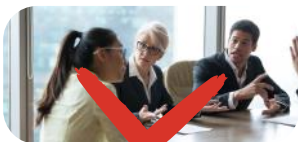

Buy-sell agreements often use life insurance policies to fund a potential buyout in the event of a partner's death.”
