Editor's Opinion



WARRINGTON is often held up as a success story of modern regional Britain and while there is no one more positive about our town than me – that narrative is beginning to fray, despite another upbeat Annual Property Review.

Beneath its economic growth lies a town grappling with deep structural challenges that raise uncomfortable questions about governance, inequality, and long-term sustainability.

The most pressing issue is financial. Warrington Borough Council's debt—once reaching around £1.8bn—has forced unprecedented scrutiny, with government-appointed envoys stepping in to oversee recovery efforts. What went wrong is now well documented: a high-risk investment strategy designed to generate income ultimately exposed the council to heavy losses, alongside a projected £130m budget gap over the next four years. This is not just an accounting problem; it is a political one. Residents will now face higher council tax and reduced services, raising the question of whether bold financial experimentation has undermined public trust.

Yet focusing solely on finances risks missing a broader paradox. Warrington's economy has grown faster than the UK average, driven by logistics, tech, and high-skilled jobs. On paper, it is one of the North's most prosperous towns. But prosperity has not been evenly shared. Pockets of deprivation, rising child poverty, and dissatisfaction with "levelling up" policies suggest that growth has been

uneven—and, for some, invisible.

This disconnect is perhaps most visible on the high street. Retail decline continues, with hundreds of shops lost over the past decade and ongoing closures highlighting the pressure from online competition and high rents. At the same time, Warrington faces significant structural change. The creation of the Cheshire and Warrington Combined Authority and a future elected mayor signals a shift in how the area is governed. Meanwhile, a new Local Plan will shape housing, infrastructure, and land use for decades to come. These developments offer opportunity—but also risk further controversy, particularly around green belt use

and urban expansion with a lack of infrastructure to support it—in particular on the highways, which still suffer gridlock on a regular basis. One could argue that the new relief road has actually worsened traffic on Bridge Foot. There are some positive signs. Investment in SEND services, for example, shows responsiveness to local needs. But isolated improvements cannot mask systemic pressures. Ultimately, Warrington's challenge is not whether it can grow—it already has—but whether it can do so fairly, sustainably, and transparently. Without addressing governance failures and social inequality, its success story may prove more fragile than it first appears.

Remembering Anne Leach – a heart of gold

THE family of a Warrington mum with a “heart of gold” who died from pancreatic cancer has shared her story to raise awareness of the exceptional care she received at St Rocco’s Hospice.

In November 2024, Anne Leach was diagnosed with pancreatic cancer, marking the beginning of a journey that would show just how strong, loving, and remarkable she was.

Anne first came to St. Rocco’s as an outpatient, where she began to receive palliative support alongside her treatment. As her illness progressed, Anne was referred to the Virtual Ward, so her pain could be carefully managed, as she continued to move in and out of hospital. By the end of October, Anne was struggling to eat, along with other symptoms, and during one hospital stay, she decided it was time to write down her final wishes to share with her family.

Anne was 74 when she died, and two of her children, Tracey and Sharon, wanted to share their and Anne’s story and how she was a truly wonderful woman, “Mum had a heart of gold and an enormous love for life, her family, and especially her grandchildren.”

Anne and her husband Dave had been together for 45 years and married for 42. Anne and Dave moved to Warrington from South Wales, and together they created a busy, loving family of seven, raising five children. Family meant everything to Anne, and that love was felt by everyone around her.

“Mum was strong-willed, fun-

loving, and full of character, she adored travelling and had been to Thailand 18 times, often staying for a month at a time. She loved a dance and a singsong in the bars and would always seek out a bingo game wherever she went. She loved to sing, laugh, and make memories.”

Sharon discovered that Anne had been quietly sponsoring a Guide Dogs puppy, Clara, for many years, receiving regular “pupdates” that the family hadn’t even known about until they were looking through some files, which reflected her generous, thoughtful nature.

In June 2025, while Anne’s sister was undergoing treatment for breast cancer, the family organised a garden party. Anne’s sister travelled up from Somerset to surprise her. Both women were going through chemotherapy, and it was a joyful occasion for the family to be able to come together. This was such a memorable occasion as sadly it became the last time the entire family was together before Anne died.

At the hospice, Anne’s care was everything the family could have hoped for and more. In her final moments, Anne was gently repositioned to keep her comfortable. She was fast asleep, not in pain, holding hands with her family. She died peacefully,

surrounded by the people she loved most and the staff allowed the family to stay with Anne for as long as they needed, which brought them great comfort.

Anne’s funeral took place on Tuesday, 10th February, and all donations received were kindly given to St. Rocco’s in Anne’s memory. Tracey and Sharon would like to continue to support St. Rocco’s, and this summer, family members plan to volunteer for a day, helping to tidy the grounds and make cups of tea. Seven of them will also be taking part in the 2026 Colour Run event.

Council to exit Redwood Bank investment for "substantial loss"

WARRINGTON Borough Council has given approval to exit its controversial investment of over £30m in Redwood Bank, following a decision by Cabinet, for a "substantial loss."

The council had received a formal offer to sell its interests in the bank for a confidential financial return.

At the meeting in early April the Cabinet discussed and approved the sale of the council's interests in the bank.

Members heard this would realise a substantial financial loss compared to the initial investment the council made into the bank in 2017. However, in exiting the bank – subject to regulatory approval – the council would be protecting itself from any future risks, and would be exiting from one of its more complex investments.

This is particularly significant, as the council continues to work hard to reduce both its debt level and the complexity of its commercial portfolio, with support from the council's government-appointed Ministerial Envoys. The council has already agreed to sell off Birchwood Park and is looking at other investments to sell as it bids to plug a budget shortfall and £1.4 billion of debt.

Cabinet member for finance, assets and investments, Cllr Denis

Matthews, said: "I believe that this is a decision in the best interests of the council at this time. We have huge financial challenges and a significant task in ensuring we can become a sustainable organisation. Focusing our resource and effort on this goal is critical.

"As we have previously acknowledged, we need to simplify our commercial portfolio, while reducing our overall level of debt to a more manageable level. Continuing to adopt this approach will enable us to prioritise our resources on providing services for our residents and working towards financial sustainability.

"Ultimately, we need to keep making measured decisions about our overall commercial portfolio to ensure we can become a modern and efficient council that provides the best possible services, while living within our means."

The investment in Redwood Bank was one of the key reasons why the council was unable to sign off its accounts, following a legal challenge by retired accountant, the late Richard Buttery.

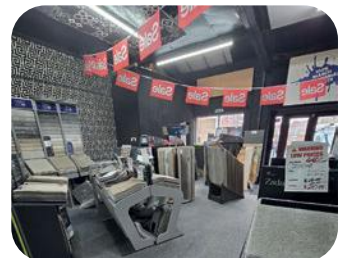

Volunteers smash Great British Spring Clean litter-picking record

OVER the two weeks of Keep Britain Tidy's Great British Spring Clean (GBSC) campaign last month, Warrington's Litter Volunteers completed 24 public team events and many more solo picks, creating a new record.

Warrington's previous GBSC record of 1,170 bags (from 2025) was smashed with a massive 1,571 bags. This is an increase of 34% on last year's record.

Warrington Litter Volunteers (WLV) includes all of Warrington's volunteer litter teams. In 2025, they were honoured to be awarded the King's Award for Voluntary Service.

This year's campaign again focused on trails, parks and hotspots and was based on multiple teams working together.

The Parks included Orford Park twice, Victoria Park, Brickfield Park, Black Bear Park, Westy Park and Longford Pool Park.

The trails included Sankey Valley Park from St Helens Border to Gatewarth, and the Trans Pennine Trail from Heatley Bollin in Lymm to Spike Island in Widnes.

Litter heroes Ambassador Tony Dixon stated: "We had no huge showcase events for this year's Great British Spring Clean but we focused on team picks with up to 20 volunteers. This worked more effectively. During GBSC, we achieved three "centuries" (over 100 bags in a single day) and one "double century" much more efficiently. The total bag count speaks for itself."

He said the volunteers' drive and motivation had been incredible. Solo pickers picked over 50% of the GBSC total. The local movement continues to grow, and there are now almost 4,000 members of litter networks and litter teams in Warrington Borough. There are 55 trained volunteers with leadership potential. In January, there were 10 teams and there will soon be 13 teams.

Volunteer Bob Towers added, "During GBSC we have grown and broadened our team volunteer base with 30 new volunteers, support from Wolves PDRL Team, New Routes Litter Team and Warrington's Hong Kong Community. In addition, 200 primary school children and scouts experienced litter picking."

James Coates from Litter Networks continued, "The 'Warrington Litter Network' of 24 ward-based Facebook Groups has existed since October 2020. With the addition of the award-winning 'Warrington Litter Volunteers' it has been an absolute pleasure to witness a plethora of 'Litter Teams' from across the town come together to deliver Warrington's Great British Spring Clean 2026 with such an outstanding bag count being achieved."

WLV Team Leader Jill Dance

added, "WLV continues to be a powerful force for good as new teams grow across the town. Our streets deserve to shine and be given the TLC they deserve."

Many volunteers find litter picking to be an incredibly mindful and, a helpful recharge – for physical and mental wellbeing. Once people experience this, they do tend to engage and stay with their chosen team.

Tony added: "We would like to thank our Mayor, Cllr. Mo Hussain for his strong and practical support in 2025-2026. We have a close working relationship with WBC, particularly Ian Brackenbury, which we value very highly."

"WLV Teams are also grateful for the support for kit from Parish Councils (Appleton, Stockton Heath, Grappenhall & Thelwall),

Warrington Voluntary Action and Co-op Community Fund."

WLV have recycled 430,000 Aluminium cans (6 tonnes) since July 2023. In 2024, they began donating cans to the Novelis charity: 174,000 cans (2.5 tonnes) so far. In this way, WLV have helped raise over £8,500, which has helped support the Orford Veterans' Hub charity.

No Fault Divorce

Divorce law in England & Wales changed in a big way 4 years ago—yet in my experience there are still people who are oblivious to it.

So-called 'no-fault divorce' was introduced in April 2022. Under the old law, anyone seeking a divorce had to plead that their marriage had irretrievably broken down and then go on to evidence this by relying on one or more of five "facts": namely, adultery, unreasonable behaviour, desertion, or a period of separation (either two years with consent, or five years with or without consent).

In practice, the old law often meant one party assigning blame but that has now gone. Although in many cases one party does feel that the other is to blame, under the new law there is no longer any need to point the finger. In fact, not only is there no need, there is no mechanism within the divorce process for doing so.

Today, a divorce application simply includes a statement by the applicant that the marriage has broken down irretrievably, and which statement is taken as conclusive. No detail. No blame. No argument.

The ability to contest a divorce has also been dramatically reduced. A respondent can only contest on limited grounds, namely no jurisdiction, invalid marriage, or that the marriage has already legally ended. In the absence of these the divorce will proceed.

But—and this is crucial—while under the new law obtaining a divorce is more straightforward, the same cannot always be said for resolving finances or child arrangements. These issues remain entirely separate from the divorce and are often where the real complexity lies.

No-fault divorce has made the process for legally ending a marriage simpler and, in many cases, less confrontational. But it is only one part of a much bigger picture arising from marriage breakdown and getting the right advice at the outset with respect to the whole picture can make a significant difference to the shape of things to come.

Five hidden signs of Prostate disease

I've been practising medicine for over a decade, and one pattern I see repeatedly is this: men arrive at my clinic having quietly lived with prostate symptoms without ever getting checked. They do this not because they're careless but because the signs are easy to explain away, and nobody had told them what to look for.

The fact most men don't know is that the prostate grows continuously throughout a man's life, and by his 50s, half of all men will have an enlarged one. This is why most men may put symptoms simply down to old age.

Five signs I'd want you to take seriously

1. Your urine stream has quietly changed

Nothing dramatic - just a little weaker, or a little slower, maybe you have to wait a moment before it starts, or you feel as though you never fully empty. As this creeps up over months, most men assume it's simply ageing and carry on however it's a sign that your prostate is quietly enlarging and pressing on the urethra. I'd rather know about it early.

2. You're waking up in the night to urinate more than once

One trip per night is ok but if you're making two or three bathroom visits between midnight and morning, that's worth raising with a doctor. An enlarged prostate can reduce how much the bladder holds overnight. Not to mention that fragmented sleep does real

damage to your heart, hormones, and mental health over time.

3. Sex feels different

This is the symptom men most rarely mention. Pain during or after ejaculation, a noticeable drop in ejaculatory force, blood in semen, or worsening erections can all point to prostate inflammation or, in some cases, early cancer. Stress and age take the blame far more often than they should. If something has changed, please tell your doctor.

4. A persistent ache in your lower back, pelvis, or hips

If it doesn't improve with rest or painkillers, pay attention. Pelvic and lower back discomfort is a recognised symptom of prostatitis, and when prostate cancer spreads beyond the gland, the bones of the pelvis and spine are frequently the first place it travels. It's probably something else entirely - but this is exactly the kind of symptom I want my patients to mention, especially in combination with the other symptoms.

5. You just feel off

If you're feeling tiredness in a way you can't explain, make sure

you get this checked. A persistent, low-grade fatigue that sleep doesn't fix, combined with a quiet sense that something isn't quite right. As a GP, when a patient tells me they "just don't feel like themselves," I listen carefully. Your body often signals a problem long before the tests confirm it.

What I'd recommend you do

Go and speak to your own GP. A PSA blood test and a brief physical examination can tell us a great deal. If you're over 50, over 40 with a family history of prostate cancer, I would encourage you not to wait for symptoms before having

this conversation.

If there is any concern at all, your GP will refer you for an MRI. A multiparametric prostate MRI is now the gold standard for good reason it gives us a precise, detailed picture of the gland without going straight to biopsy. It picks up significant cancers early, rules out unnecessary worry when everything looks fine, and means that if a biopsy is needed, it will be targeted and accurate.

Prostate cancer detected early is nearly always curable.

The most important thing you can do today is simply book the appointment.

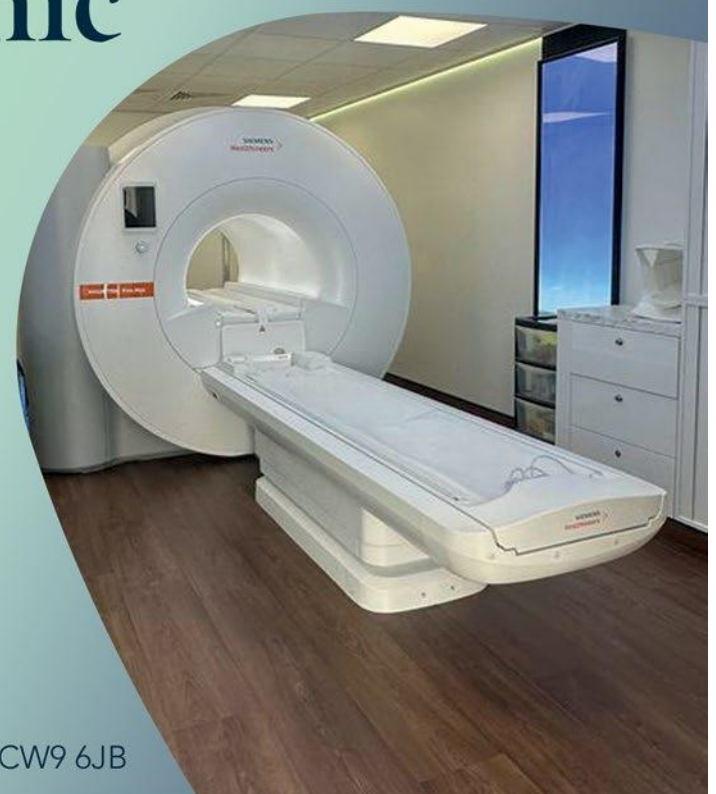

Spotlight on Local History with James Balme

A visit to Norton Priory - The most excavated monastery in Europe

Close to Warrington in nearby Norton stands the historical remains of Norton Priory. The site is officially the most excavated monastery in Europe.

A visit to the ruins that remain today is a journey well worth making and one that appeals greatly to those who are interested in the medieval history of the area. I decided to visit once again recently having not been to the Priory for many years.

The weather was glorious and the remains of the monastery was bathed in warm spring sunshine. A visit here is always a peaceful one and there is a very calming atmosphere throughout the site. As well as exploring the remains of the monastery a visit to the special exhibition in the museum was a must to see the stunning artefacts on display found at Norton Priory over many past excavations. Even today excavations are still taking place on site and I've little doubt that they will continue in the coming years with many more historical objects unearthed.

Norton Priory Museum & Gardens, situated at Norton on the edge of Runcorn, is one of Cheshire's hidden gems and considered to be the most important monastic remains in Cheshire. The site was also once home to a medieval church. Today

the site comprises of the remains of the abbey complex dating from the 12th to 16th centuries, and also an 18th century country house. The Priory was established in the 12th century as an Augustinian foundation by William Fitz Nigel, 2nd Baron of Halton and was raised to the status of a mitred abbey in 1391. Two families have links to the site and these being the Dutton family and the Brooke family. The Duttons supported and engaged with Norton Priory as a monastic site up until the Dissolution of monasteries in 1536 during the reign of king Henry VIII. The Brooke family made Norton Priory their home and Sir Richard Brooke building a Tudor house at the site and incorporating part of the abbey secured the site as the home of the Brooke family between 1545 and 1921, when they left the site to move to a new home in Worcestershire.

Today Norton Priory boasts a world class museum where literally thousands of objects discovered at the site are on public display bringing the history of the priory to life. One of the most impressive objects in the museum on display

today is the double life-size St Christopher statue. It is very likely that this statue would have been commissioned to mark the site attaining abbey status in 1391. The priory was designated a scheduled monument on 24th July 1928 and later to be given Grade I listed status in April 1970. If you are visiting Cheshire then a visit to Norton Priory is a must for anyone who has an interest in seeing the wonderful remains and artefacts that remain at the priory to this day.

will have stalls from local restaurants and traders, together with a variety of street entertainment.

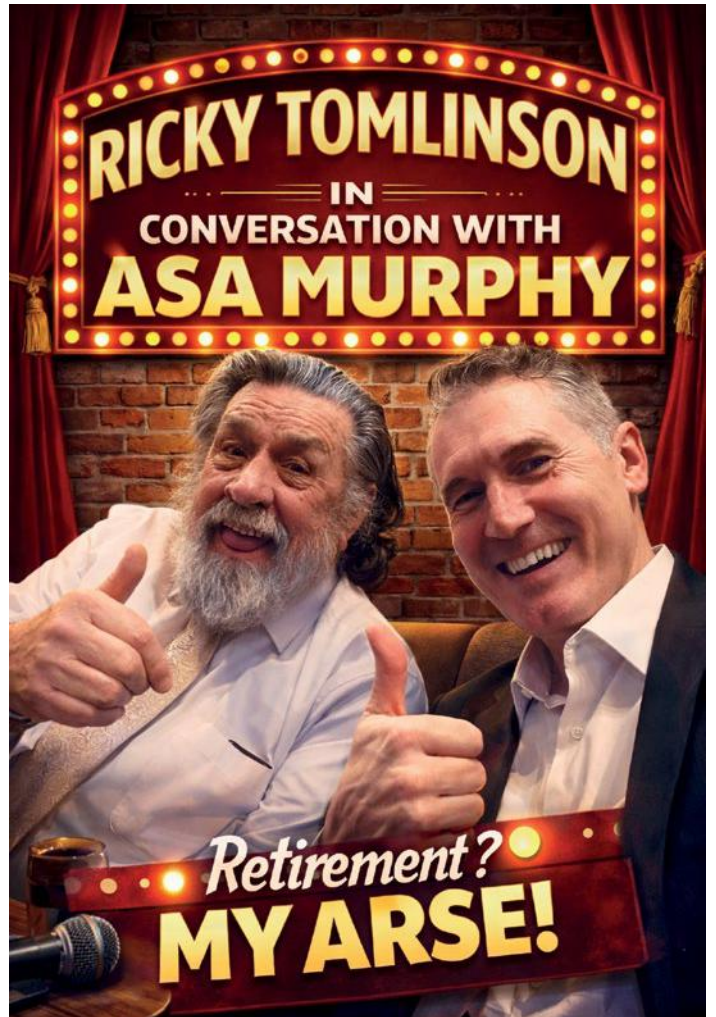

HMRC Targets Directors' Loans in crackdown on Small Business Tax gap

HMRC has launched a major consultation that could significantly change how small companies report transactions with their owners.

At the heart of this is a proposed clampdown on directors' loan accounts and loans to shareholders (known as "participators"). While that may sound technical, the practical impact is straightforward: if you run a limited company and move money in or out beyond salary and dividends, these changes could affect you.

Why is HMRC acting?

The move is driven by the growing "tax gap" – the difference between the tax HMRC believes should be paid and what is actually collected. In 2024, the small business corporation tax gap reached £14.7 billion, representing around 40% of total liabilities. HMRC believes a significant portion of this shortfall is linked to how funds move between companies and their owners.

In its consultation, HMRC points to a "failure to distinguish between the company's and the participator's monies", highlighting how easily the line between business and personal finances can become blurred.

What is being proposed?

In essence, HMRC wants much more detailed reporting of transactions between close

companies and their participators. This would go far beyond current requirements. It would include not just obvious items like dividends, but also cash movements, bank transfers, asset sales and purchases between the company and its owners, and any other transfer of value. In practical terms, almost every financial interaction between a company and its shareholders could fall within scope.

Directors' loan accounts under the spotlight

Directors' loan accounts are very much in the spotlight. These have long been an area HMRC monitors closely. At present, if a company lends money to a shareholder and it is not repaid within the required timeframe, a temporary tax charge arises—commonly known as Section 455 tax. This can be reclaimed once the loan is repaid.

Under the new proposals, however, HMRC is seeking far greater visibility. Companies may be required to report the date and amount of repayments, details of any loans written off or released, and ongoing movements throughout the year. The intention is to ensure that the correct tax is paid at the right time, and that any reliefs claimed are justified.

Who will be affected?

In terms of who is affected, the answer is simple: almost all small limited companies. Under UK

tax rules, most owner-managed businesses are classed as "close companies", meaning they are controlled by a small number of shareholders or directors. The proposals would therefore apply widely across the small business sector.

They would also extend to corporate shareholders and group structures, which HMRC acknowledges could add complexity where there are significant intra-group transactions.

What is excluded?

There is one notable exception. Payments already reported through PAYE, such as salary, are likely to be excluded as HMRC already receives this information through its Real Time Information system. Beyond that, however, very little appears to fall outside the proposed scope.

Why this matters

While the stated aim is to tackle tax avoidance, the impact will be much broader. Directors' loan accounts are often used for entirely legitimate reasons, such as managing cash flow or dealing with timing differences between income and personal drawings.

The concern for many business owners is not the principle, but the practical burden. More detailed reporting will inevitably mean more record-keeping, greater scrutiny from HMRC, and less flexibility in how funds are moved.

Even relatively straightforward transactions could require careful tracking, including dates, amounts and counterparties.

The bigger picture

Viewed more broadly, this is part of a clear direction of travel. HMRC is increasingly focused on close companies because of the overlap between ownership and control. Where the same individuals both run and benefit from a company, the boundary between company funds and personal funds can become less distinct.

HMRC believes this creates both opportunity for deliberate non-compliance and a higher risk of genuine mistakes.

What should business owners do?

For now, these proposals are not yet law. However, they send a strong signal about where things are heading. Business owners would be wise to take note. Keeping company and personal finances clearly separated, maintaining accurate and up-to-date directors' loan accounts, and avoiding informal or undocumented transactions will become increasingly important.

The reality is that the days of treating the company bank account as a flexible extension of personal finances are likely coming to an end.

While Smith's career at Warrington was defined by three Challenge Cup titles (2009, 2010, 2012) and two League Leaders' Shields (2011 and 2016), his next chapter is strictly recreational.

The move to Indonesia offers a "six-hour flight" to visit his children rather than a 24-hour one, and Smith is eager to embrace a slower pace of life.

He has expressed excitement about pursuing hobbies far removed from the high-pressure

world of Super League coaching, including fishing in Indonesian waters and learning how to surf.

"I really enjoyed my nine years at the club," Smith told supporters. "I'd like to think the club has progressed... and is now in a position that means they can go on to bigger and greater things".

He said one of his greatest memories during his time at the club was the homecoming parade after the club won at Wembley during his first season in charge.

"I've never seen anything like it before. It was incredible and something I will never forget."
