WHEREAS Youth of the country need to be made conscious about the need to selflessly participate in the community activities.

WHEREAS the people at large in the society need to be made conscious about the need to selflessly participate in the community activities.

WHEREAS numerous not-for-profit organizations across the country are involved in the onerous task of nation building across various walks of life, hereafter referred to as Non-Governmental organizations or "NGOs".

WHEREAS NGOs constantly need the active help and support of youth and public at large.

WHEREAS the nation's development and transformation has four important stakeholders to it, and there is a felt need to organize their participation in the acts of nation building and developmental activities. These are :

WHEREAS the target of all these four distinct entities is community and its development, meaningful interaction across these entities is needed for effective social transformation.

WHEREAS NGOs develop good prototypes, they can also help government in implementation of government schemes. NGOs raise funds but they usually fall short of attracting volunteers. Often, donors who make contributions to the NGOs remain uninvolved. Youth for Seva recognizes the need for this phenomenon to change. The Trust believes that it is vital to focus on human resource development – attracting, training, deploying and motivating talent to do productive work.

WHEREAS Previously, the CSR initiatives by the corporates were about giving money and getting reports. Today they are encouraging voluntary involvement of their employees in community service. There is a need for someone to facilitate the corporates in their endeavours to promote volunteerism and community activity amongst their employees.

WHEREAS The academic institutions are another stakeholder of the Trust as they form an induction ground to recruit the best talent to the developmental sector. Introducing

- 4 The Trust shall be administered by a Board of Trustees constituted under this declaration of Trust and in accordance with the terms and conditions enumerated hereinafter and the Rules and Regulations framed there under.
- 5 The objects for which the Trust is being established are:
  - 5.1 To promote the spirit of volunteerism and social service amongst the youth and people of the society.
  - 5.2 To raise awareness of people about social issues.
  - 5.3 Youth For Seva shall be an equal opportunity organization. It shall welcome, respect and celebrate social, gender, religious, linguistic and other diversities.
  - 5.4 To create a platform so that the youth and people at large – hereafter called “Volunteers” - in the society can take part in the act of nation building and social change.
  - 5.5 To be a platform to accommodate, organize, direct and enable the disparate needs and abilities of various entities in the country all bound by the singular vision of developing and transforming the nation, and in line with the objects of the Trust.
  - 5.6 To accommodate the time constraints of various sections of the society. A design goal for the platform will be to enable the theory that “all have to give some time and some have to all time”.
  - 5.7 To work with citizens in inspiring them for voluntary community initiatives and to map them to address a particular need of the community.

- 5.15 To aid and enable the NGOs in their human resource development endeavours consisting of attracting, training, deploying and motivating talent to do productive work.
- 5.16 To work collaboratively with other NGOs in the spheres of engaging, training and deployment of volunteers.
- 5.17 To develop and deliver capacity building and executive training programmes for NGOs.
- 5.18 To engage in social innovation and incubation programs: Youth for Seva might opt to not run these programs directly and limit itself to just providing the support needed to incubate and grow the ideas and nurture social entrepreneurs.
- 5.19 To help corporates in executing their CSR initiatives involving, but not limited to, encouraging their employees to volunteers, create the culture of engaging and motivating employees to volunteer.
- 5.20 To provide consultancy services to the corporates in designing and operationalizing their CSR programmes and activities in line with the objects defined of YFS.
- 5.21 To work with universities and other academic institutions in designing and discharging academic programs on volunteering and community development. It may participate in activities such as class room sessions, seminars and field visits. YFS may also facilitate an internship programme to further its objects.

- 5.23 To conduct discourses, debates, seminars, meetings, workshops, and/or classes to propagate and disseminate knowledge, information and understanding in any area of study and research with which the Trust is concerned and to promote any of the objects of the Trust.
- 5.24 To print and publish books, magazines, News bulletins, newsletters and to employ all means of communication to spread knowledge and information on any field with which the trust is concerned.
- 5.25 To conduct certification courses on NGO capacity building, volunteering, etc. solely or jointly with other likeminded NGO and/or governmental organizations
- 6 All activities of the Trust shall be without profit motive and shall benefit public at large without distinction of caste, creed, religion or gender.
- 7 The Trust shall maintain separate sets of books of accounts in accordance with the provisions of Income Tax Act (1961).
- 8 The accounting year of the Trust shall be the financial year ending on 31<sup>st</sup> March every year.
- 9 The Trust shall accept contributions and gifts and own and possess properties and do all such things as may be necessary or incidental for attaining the objects of the Trust.
- 10 The Trust and Trust Funds shall be irrevocable at all times.

- 19.6 On his being expelled by the Board of Trustees for his acting or having acted against the interest of the Trust, by a majority vote, provided such trustee has been given a reasonable opportunity of explaining his conduct to the Board of Trustees.
- 20 Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
- 21 Any vacancy caused in this office of the Trustees under the circumstances described in clause 18 & 19 above shall be filled up by the Trustees themselves in consultation with and approval of the advisory committee and the Trustee so nominated shall hold office for the unexpired term of the Trustee vacating the office.
- 22 Any vacancy caused in the advisory committee constituted under clause (13) shall be filled up by inviting any prominent person involved in social service and known for probity in public life to serve on the committee.
- 23 The Board of Trustees shall elect an Executive Council consisting of the following office bearers to be responsible for the overall operations of the Trust:
- 23.1 President
  - 23.2 Vice-President
  - 23.3 General Secretary
  - 23.4 Organizing Secretary
  - 23.5 Treasurer
- 24 The Board of Trustees shall determine the term of office, powers, duties, responsibilities and other terms and conditions connected with Executive Council.

Trust shall be invested in the modes specific under the provisions of the Income Tax Act, 1961 governing charitable Trusts.

28.2 To receive any money or other assets in any shape or forms a gift or donation and to hold the same as Capital Fund and /or apply it for furthering the objects of the Trust.

28.3 To invest the funds from time to time in such manner as may be permitted under the provisions of Income Tax Act, and to dispose of, alter or vary the investment from time to time to realise the investment.

28.4 To compromise, compound, abandon, submit to arbitration or otherwise institute any actions, suits, proceedings, claims or other things, whatsoever, arising out of the administration of the Trust Fund, and to enter into, give execute and do such agreements, instruments and composition or arrangements, releases and other things, as may seem expedient, without being liable or responsible for any loss occasioned by any act or things so done by them in good faith.

28.5 To acquire or to dispose of through mortgage, hire, lease or otherwise movable or immovable, tangible or intangible properties, and rights and benefits and to manage the same.

28.6 To receive, Collect or realise or cause collection or realisation of all income that accrue or become due on all or any investment and to grant receipts and discharges.

28.7 To represent the Trust in all Court (Original and appellate) or before judicial or quasi-judicial authorities and other authorities, departments of Government, Semi-Government or local authority. For this purpose, the Board of trustees may designate one or more Trustees by a resolution.
