Narayanappa, presently residing at 8/28, "Ajitashree", Bull Temple Road, Basavanagudi, Bangalore-560004, hereafter referred to as the "Author of the Trust" Witnesseth as following.

WHEREAS Youth of the country need to be made conscious about the need to selflessly participate in the community activities.

WHEREAS the people at large in the society need to be made conscious about the need to selflessly participate in the community activities.

WHEREAS numerous not-for-profit organizations across the country are involved in the onerous task of nation building across various walks of life, hereafter referred to as Non-Governmental organizations or "NGOs".


WHEREAS NGOs constantly need the active help and support of youth and public at large.

- iii. For-profit Corporations: Corporates involved in philanthropic corporate social responsibility initiatives also known as CSR programs
- iv. Citizens: Ordinary citizens who might not have been part of any NGO.

WHEREAS the target of all these four distinct entities is community and its development, meaningful interaction across these entities is needed for effective social transformation.

WHEREAS NGOs develop good prototypes, they can also help government in implementation of government schemes. NGOs raise funds but they usually fall short of attracting volunteers. Often, donors who make contributions to the NGOs remain uninvolved. Youth for Seva recognizes the need for this phenomenon to change. The Trust believes that it is vital to focus on human resource development – attracting, training, deploying and motivating talent to do productive work.

WHEREAS Previously, the CSR initiatives by the corporates were about giving money and getting reports. Today they are encouraging voluntary involvement of their employees in community service. There is a need for someone to facilitate the corporates in their endeavours to promote volunteerism and community activity amongst their employees.

WHEREAS The academic institutions are another stakeholder of the Trust as they form an induction ground to recruit the best talent to the developmental sector. Introducing

AND WHEREAS creation of a trust for realizing the above ideas has become a necessity, the author of the trust who himself has devoted his life for social service is desirous of creating a trust for recruiting, enthusing and engaging youth in social service and act as a network for various social service organizations, corporates and the like. He has set apart a sum of Rs.10,001/- for creation of a trust to fulfil the objects more elaborately described hereafter. Now therefore this declaration of trust witnesses:-

- The name of the Trust shall be "Youth for Seva", referred to as YFS hereinafter. The principle office of the trust shall be situated at Jnana Giri, 75/76, 4th Cross, 2nd Main, Soudamini Layout, Konanakunte, Bangalore- 560062. The registered office may be shifted to such other place as the Trustees may deem it necessary if it is expedient to do so.
- 2 The Author of the Trust has set apart a sum of Rs. 10,001/- for the creation of the Trust and in holding the same in the trust and the said sum of Rs. 10,001/- shall be deemed to be the property of this Trust. The property of the Trust will include:
 - 2.1 The aforesaid sum of Rs.10, 001/-
 - 2.2 Such contributions and donations, endowments as may be made by the public, institutions and the like for the purpose of advancing the implementation of the objects and purpose of this Trust.
 - 2.3 Such acquisitions and additions that may be made by the Trustees.
- 3 Founding Values of Youth for Seva trust include (i) Sustainable development, (ii) Social harmony, (iii) National integrity, and (iv) Respect for pluralism. These




founding values shall form and guide the formulation and articulation of the organization's vision.

- 4 The Trust shall be administered by a Board of Trustees constituted under this declaration of Trust and in accordance with the terms and conditions enumerated hereinafter and the Rules and Regulations framed there under.
- The objects for which the Trust is being established are:
 - 5.1 To promote the spirit of volunteerism and social service amongst the youth and people of the society.
 - 5.2 To raise awareness of people about social issues.
 - 5.3 Youth For Seva shall be an equal opportunity organization. It shall welcome, respect and celebrate social, gender, religious, linguistic and other diversities.
 - 5.4 To create a platform so that the youth and people at large hereafter called "Volunteers" - in the society can take part in the act of nation building and social change.
 - 5.5 To be a platform to accommodate, organize, direct and enable the disparate needs and abilities of various entities in the country all bound by the singular vision of developing and transforming the nation, and in line with the objects of the Trust.
 - 5.6 To accommodate the time constraints of various sections of the society. A design goal for the platform will be to enable the theory that "all have to give some time and some have to all time".
 - 5.7 To work with citizens in inspiring them for voluntary community initiatives and to map them to address a particular need of the community.

- 5.8 To groom the volunteers to be the positive change champions the process of grooming the change champions will be multi-dimensional in nature as the change champions require growth in all three spheres of knowledge, competencies and inspiration. Youth for Seva will strive to enable such a development of the change champions.
- 5.9 The Trust shall have "engaging volunteers" as its core focus. Depending on the volunteers' interests Youth for Seva will work in all areas of development including, but not limited to, employability, education, health care, advocacy, research, publication, sale and distribution of publications of both YFS and other partner entities, vulnerable communities, disabilities, disaster management, and others.
- 5.10 Youth for Seva shall actively participate and promote international volunteering. YFS shall strive to send volunteers from India to other countries to enable them to develop a global mind-set and reinforce their social responsibilities. It shall also strive to enable volunteer exchange programs by accepting and engaging volunteers from other countries.
- 5.11 Youth for Seva shall strive to provide human resources and volunteers to strengthen NGOs in different fields. Specialized talent development needed for running such NGOs is YFS' aim.
- 5.12 To create successful social entrepreneurs.
- 5.13 To be the nodal centre for continually engaging and partners.
- 5.14 To offer services to the governmental and international agencies in assessing the impact and effectiveness of various schemes, suggesting alternative models

to tackle social issues, and enabling effective implementation of schemes with active citizen participation.

- 5.15 To aid and enable the NGOs in their human resource development endeavours consisting of attracting, training, deploying and motivating talent to do productive work.
- 5.16 To work collaboratively with other NGOs in the spheres of engaging, training and deployment of volunteers.
- 5.17 To develop and deliver capacity building and executive training programmes for NGOs.
- 5.18 To engage in social innovation and incubation programs: Youth for Seva might opt to not run these programs directly and limit itself to just providing the support needed to incubate and grow the ideas and nurture social entrepreneurs.
- 5.19 To help corporates in executing their CSR initiatives involving, but not limited to, encouraging their employees to volunteers, create the culture of engaging and motivating employees to volunteer.
- 5.20 To provide consultancy services to the corporates in designing and operationalizing their CSR programmes and activities in line with the objects defined of YFS.
- 5.21 To work with universities and other academic institutions in designing and discharging academic programs on volunteering and community development. It may participate in activities such as class room sessions, seminars and field visits. YFS may also facilitate an internship programme to further its objects.

- 5.22 To organize seminars and conferences to enable cross pollination of ideas, exchange of best practices and to help enable inter-NGO volunteer-stakeholder networking.
- 5.23 To conduct discourses, debates, seminars, meetings, workshops, and/or classes to propagate and disseminate knowledge, information and understanding in any area of study and research with which the Trust is concerned and to promote any of the objects of the Trust.
- 5.24 To print and publish books, magazines, News bulletins, newsletters and to employ all means of communication to spread knowledge and information on any field with which the trust is concerned.
- 5.25 To conduct certification courses on NGO capacity building, volunteering, etc. solely or jointly with other likeminded NGO and/or governmental organizations
- 6 All activities of the Trust shall be without profit motive and shall benefit public at large without distinction of caste, creed, religion or gender.
- 7 The Trust shall maintain separate sets of books of accounts in accordance with the provisions of Income Tax Act (1961).
- 8 The accounting year of the Trust shall be the financial year ending on 31st March every year.
- 9 The Trust shall accept contributions and gifts and own and possess properties and do all such things as may be necessary or incidental for attaining the objects of the Trust.

10 The Trust and Trust Funds shall be irrevocable at all times.

- 11 The funds and income of the Trust shall be solely utilised towards achievement of the objects and no portion of it shall be utilised for payment to Trustees by way of profit, interest, dividends, etc.
- 12 The Trust shall be administered by a Board of Trustees initially constituted by the Author of the Trust. Following are the Trustees of Youth for Seva.
 - 12.1 Sri S. Rajanna, aged about 64 years, Son of Sri Surappa, presently residing at 54, 1st Main,2nd Cross, 3rd Phase, 4th Block, Banashankari 3rd Stage, Bangalore – 560 085.
 - 12.2 Sri Kiran D. M. aged about 44 years, Son of Sri D.Manavalan, presently residing at 884, "Vismaya", 1st E Main, 2nd Phase, Girinagar, Bangalore 560 085.
 - 12.3 Sri Prasanna Ganapathi Basavapatna, aged about 44 years, Son of Sri Anantha Subbaraya B.K., presently residing at 11, 8th Main, Avalahalli BDA Layout, BSK 3rd Stage, Bangalore 560 085.
 - 12.4 Sri Mahesh Vaidya, aged about 38 years, Son of Sri Ramesh Vaidya, presently residing at 165, "Padmam", 28th Cross, 14th Main, Banashankari 2nd Stage, Bangalore 560 070.

- 13 The author of the trust hereby constitutes an advisory committee comprising of eminent persons known for their probity in public life and involvement in the field of social service to guide and advise the Board of trustees in the matter of administering the activities and carrying out the objects of the trust.

- 14 The Board of Trustees shall consist of not more than thirteen trustees and not less than five.
- 15 The Board of Trustees shall have the power to co-opt trustees from time to time subject however to the limit of thirteen trustees.
- 16 The Trustees shall hold the office for a period of three years from the date of this Deed or from the date of the appointment and thereafter as nearly as may be a third (that is 1/3) of them shall retire by rotation after the expiry of 2 years. In calculating the 1/3 fraction referred to in this sub clause, fraction less than half shall be ignored and fraction more than half shall be rounded off to the next higher number. The retirement shall be in accordance with the seniority of the Trustees. In determining the seniority the duration of holding the office of the Trustees shall be the criteria. Retiring Trustees shall be eligible for reappointment. Among the trustees of the same seniority of the duration the senior in the age among them shall retire.
- 17 Retirement of the 1st batch of Trustees shall take place after the expiry of 3 years from this day. Thereafter the 2nd batch will retire after the next term and finally the 3rd batch will retire after the Third Term and thereafter the retirement process is automatic.
- 18 All the Trustees shall be Indians or persons of Indian origin.
- 19 A Trustee shall cease to hold the office:
 - 19.1 On his death



- 19.3 On his Conviction of Criminal offence involving moral turpitude

- 19.6 On his being expelled by the Board of Trustees for his acting or having acted against the interest of the Trust, by a majority vote, provided such trustee has been given a reasonable opportunity of explaining his conduct to the Board of Trustees.
- 20 Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
- 21 Any vacancy caused in this office of the Trustees under the circumstances described in clause 18 & 19 above shall be filled up by the Trustees themselves in consultation with and approval of the advisory committee and the Trustee so nominated shall hold office for the unexpired term of the Trustee vacating the office.
- 22 Any vacancy caused in the advisory committee constituted under clause (13) shall be filled up by inviting any prominent person involved in social service and known for probity in public life to serve on the committee.
- 23 The Board of Trustees shall elect an Executive Council consisting of the following office bearers to be responsible for the overall operations of the Trust:
 - 23.1 President
 - 23.2 Vice-President
 - 23.3 General Secretary
 - 23.4 Organizing Secretary
 - 23.5 Treasurer
- 24 The Board of Trustees shall determine the term of office, powers, duties, responsibilities and other terms and conditions connected with Executive Council.

The posts of President, Vice-President, General Secretary and Treasurer shall be held by the Trustees. However, the Board of Trustees may co-opt any person enjoying its trust and confidence for the post of Organizing Secretary.

- 25 The President shall preside over the meetings of the Board of Trustees and shall look after the overall management of the Trust.
- 26 The Organizing Secretary shall normally be responsible for the day to day conduct of the activities of the Trust.
- 27 The Treasurer shall keep or cause to be kept proper books of accounts and record or cause to be recorded the Receipts and payments and also maintain or cause to be maintained documents relating to these transactions. The accounts shall be audited once a year by a chartered accountant empowered to audit the accounts of a Joint Stock Company. In the absence of a Treasurer, the Board of Trustees may assign the duties of the Treasurer to any other Trustee.
- 28 With a view to carrying out the objects of the Trust herein above mentioned and to manage and administer the funds of the Trust and without prejudice to the generality of any powers hereby or by law conferred or implied or vested in the Board of Trustees, The Board of Trustees shall have following powers:
 - 28.1 To apply and use the funds for all or any of the objects of the Trust and / or to accumulate the surplus unapplied portion of income and invest the same, subject to the provisions of the Income Tax Act, 1961, as amended from time to time, relating to accumulation of income and investment thereof. Trust shall be invested in the modes specific under the provisions of the Income Tax Act, 1961 governing charitable Trusts.

- 28.2 To receive any money or other assets in any shape or forms a gift or donation and to hold the same as Capital Fund and /or apply it for furthering the objects of the Trust.
- 28.3 To invest the funds from time to time in such manner as may be permitted under the provisions of Income Tax Act, and to dispose of, alter or vary the investment from time to time to realise the investment.
- 28.4 To compromise, compound, abandon, submit to arbitration or otherwise institute any actions, suits, proceedings, claims or other things, whatsoever, arising out of the administration of the Trust Fund, and to enter into, give execute and do such agreements, instruments and composition or arrangements, releases and other things, as may seem expedient, without being liable or responsible for any loss occasioned by any act or things so done by them in good faith.
- 28.5 To acquire or to dispose of through mortgage, hire, lease or otherwise movable or immovable, tangible or intangible properties, and rights and benefits and to manage the same.
- 28.6 To receive. Collect or realise or cause collection or realisation of all income that accrue or become due on all or any investment and to grant receipts and discharges.
- 28.7 To represent the Trust in all Course (Original and appellate) or before judicial or quasi-judicial authorities and other authorities, departments of Government, Semi-Government or local authority. For this purpose, the Board of trustees may designate one or more Trustees by a resolution.

- 28.8 To sign and verify all pleadings, memoranda of appeal, petitions and applications of all kinds, and to engage lawyers and other professionals and to take all such other necessary steps.
- 28.9 To borrow or raise any money that may be required by the Trust upon such terms as may be deemed fit and to secure any money so borrowed by mortgage or charge of all or any part of the assets belonging to the Trust.
- 28.10 To open and maintain accounts with the Scheduled Bank/s and authorise operations of such account by any of the members of the Board of Trustees jointly or severally and to draw, accept, endorse, discount and / or negotiate negotiable and quasi-negotiable instruments on behalf of the Trust.
- 28.11 To pay out of the Trust's funds, honorarium, salaries, wages, rent, building maintenance, repairs and other expenses relating to the Trust, its administration, management of its activities or its other affairs.

The Board shall be entitled to frame, constitute and regulate the procedures of such committee or sub-committees.

- 28.15 To decide all questions arising in the administration of the Trust and including all questions relating to the interpretation of these presents, the administration of any institution maintained by the Trust or concerning anything or any matter relating to, connected with or arising out of, these presents or the operation thereof. The decision of the Board in all or any of the matters aforesaid shall be final.
- 28.16 To conduct the activities of the Trust in accordance with the stipulation set out herein. 


