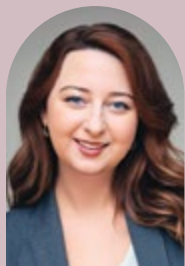

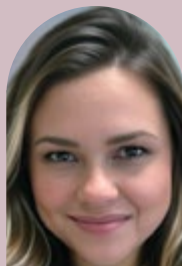

A Look Back at 2024

A Message from ASRM CEO Jared Robins, MD, MBA

As I reflect on the past year, I am incredibly proud of the tremendous progress ASRM has made in advancing our mission to improve the quality of reproductive healthcare worldwide. 2024 was remarkable for our organization, and it is marked by key accomplishments that drive our work.

Advocating for Member Protection

The Alabama Supreme Court ruled that, for the sake of civil liability, frozen embryos are equal to live-born children. As a result, the IVF clinics in Alabama immediately stopped providing care. ASRM sprang into action by providing our members in Alabama with a platform to discuss the case and their responses. We partnered with RESOLVE, the Alabama Medical Society, and lobbyists to advocate for solutions to restore clinical care in the IVF clinics. I met with patients and HHS Secretary of Health Xavier Becerra to discuss the importance of IVF in Alabama and joined more than 200 patients at the Alabama State Capital to talk about the ruling with legislators.

ASRM went to the White House to discuss women's reproductive health with President Biden's senior staff. ASRM wrote an Amicus brief to oppose the court's ruling, attended press conferences, wrote opinion pieces for the media, and met with politicians and their staff. The Alabama Congress passed legislation enabling clinics to restart operations. Unfortunately, this did not reverse the Supreme Court decision, and this battle continues.

The ASRM Center for Policy and Leadership launched CPL PRIMED this year. This exciting program provided 12 members with intensive online and in-person training to teach them to be better advocates. The success of this program was demonstrated by the capstone projects the participants presented at ASRM 2024 in Denver. See pages 16-17 for more details on CPL PRIMED.

Advocating for Increased Access to Care

A significant focus of ASRM's Office for Advocacy is improving access to care. This past year, we were successful in helping obtain an insurance mandate in California and expanding federal government coverage from the Office of Professional Management. With these coverages, we have helped improve access to ART and other fertility care for more than 60 million people. We continue to fight for broader insurance coverage, improved patient education, and greater geographic access to fertility specialists. This initiative aligns directly with our mission to make fertility care available to all who need it, regardless of socioeconomic status or location.

Five-Year Strategic Plan

In 2024, we took a monumental step forward with the development of our five-year strategic plan. This plan serves as the foundation for the future of ASRM and will lead to many projects to improve membership value. Read more about the plan on page 3 of this report.

Global Partnership Expansion

ASRM is a global society with members hailing from over 100 different countries. We value the importance of our international partnerships, and, in 2024, we took significant strides to formalize relationships with fertility societies from across the globe. ASRM held our first embryo transfer course at the Turkish Society for Reproductive Medicine annual conference. Drs. Amato, Barnhart, and I, along with other members of ASRM, were inducted into the inaugural class of the Indian College for Reproductive Medicine. We attended our first meeting of the Egyptian Foundation of Reproductive Medicine and Embryology (EFRE) and contributed to guideline development. In collaboration with the University of Michigan and the Fertility Society of Ghana, ASRM held a simulation and training program for over 70 Ghanaian Residents and Fellows training in Fertility and Reproductive Medicine. We also held our first combined business of medicine training program with the Canadian Fertility and Andrology Society (CFAS). ASRM continued our essential work with the World Health Organization, promoting healthy communication among fertility healthcare providers.

Looking Ahead

As we look ahead, I am confident that these initiatives, along with our ongoing efforts in research, education, and advocacy, will continue to elevate the field of reproductive medicine. With our five-year strategic plan guiding us, ASRM is well-positioned to meet the evolving needs of our members and to continue advocating for access to care and innovative research that benefits patients worldwide.

I want to take this opportunity to thank each and every one of you—our members, partners, and stakeholders—for your unwavering support and dedication to reproductive medicine. Together, we will continue to shape the future of fertility care and make a lasting difference for individuals and families everywhere.

ASRM Career Pathway Program

ASRM was excited to continue the Career Pathway Program, an innovative initiative aimed to inspire and engage the next generation of reproductive health professionals. The program brought together a diverse group of participants, including four medical students from the University of Colorado Anschutz School of Medicine, 24 embryology students from Colorado State University, and 15 mentors from the field of reproductive medicine.

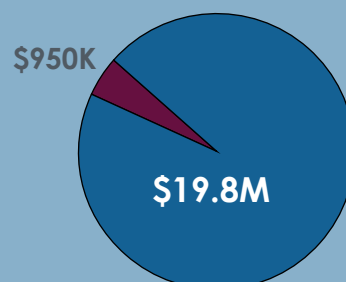

ASRM launched a combined postcard writing, radio ad, and social media campaign in 10 states with ballot measures seeking to preserve reproductive freedoms. The measures passed in 7 of 10 states, enshrining the right to abortion in these states' Constitutions. Thank you to the members who made videos supporting these ballots in their home states and everyone who helped write the over 600 postcards sent to undecided voters at ASRM 2024!



Following the Alabama Supreme Court's *LePage v. Mobile Infirmary Clinic* decision, in which they ruled that frozen embryos are the legal equivalent of children and effectively halted fertility care across the state, ASRM worked tirelessly with partners hosting town halls, attending key advocacy events, and conducting media interviews to condemn the court's ruling and demand that protections for IVF be reinstated.

ASRM released a series of one-pagers designed to cut through misinformation around IVF, including why multiple embryos are often necessary to establish a pregnancy, a breakdown of government oversight of IVF, and how politicians can materially support IVF.

ASRM worked alongside Equality CA, RESOLVE, and additional fertility and advocacy groups to pass SB 729 in California this year, bringing the number of Americans with a form of coverage for fertility treatments to 60 million!



The first-ever ASRM IVF scorecard was released this year, preparing members for the polls by providing comprehensive information on how all sitting members of Congress have historically voted on bills related to IVF, reproductive rights, and other causes important to ASRM's mission.

Advancing Reproductive Medicine Through Information and Leadership

The Center for Policy and Leadership was prominently represented at key events this year, including the eighth Annual Conference on Bioethics, hosted by UTMB's Institute for Bioethics and Health Humanities, and a Capitol Hill briefing for members of the House of Representatives and their staff. Notably, CPL Director Becca O'Connor attended the 2024 Presidential State of the Union Address and engaged in discussions with high-level officials, including US Health and Human Services Secretary Xavier Becerra, as the guest of Congressman Jamie Raskin (D-MD-08).

The inaugural cohort of the CPL's PRIMED (Preparing Experts in Reproductive Medicine to Engage Decisionmakers) advocacy training program achieved remarkable success. The diverse group, consisting of physicians, nurses, embryologists, and mental health professionals, underwent comprehensive education sessions facilitated by policy experts and ASRM leaders. Noteworthy moments included their participation as guests of the Senate Majority Leader, attendance at a press conference, and witnessing floor proceedings during a crucial vote on the Right to IVF Act.

In September 2024, the cohort made a significant impact on Capitol Hill. Armed with refined advocacy skills acquired throughout the program, the scholars fervently lobbied Congressional leaders and staff for improved and equitable accessibility to reproductive medicine, particularly in infertility care. Their advocacy efforts extended to visiting ASRM's DC headquarters, touring and conducting meetings with lawmakers and staff at the Capitol, visiting the White House and Supreme Court, and observing sessions on the United States House of Representatives floor.

Additionally, in October, cohort members showcased their Capstone Projects at ASRM's Annual Scientific Congress and Expo in Denver, solidifying their commitment to advancing reproductive medicine and advocating for better access to care.

A Diverse Community Impacting Reproductive Medicine

To shape its 2025-2030 Strategic Plan, ASRM conducted a comprehensive needs assessment of current and former members to identify the best ways to serve its membership and address gaps in member benefits. Released in 2024, the plan places a strong emphasis on member engagement through key objectives such as developing strategies to engage new and associate members, increasing accessibility and usage of educational materials, optimizing communication channels with members and stakeholders, and demonstrating member-specific value to enhance satisfaction.

These efforts are supported by a deep understanding of our membership, as reflected in key statistics that highlight who we serve and the impact of our initiatives.

Making a Global Impact

ASRM's global reach is reflected in its **1,596 members** from **106 countries**, with **Japan, India, Canada, Mexico, and Australia** leading in representation outside the United States. In 2024, **1,124 international attendees** came to ASRM 2024 in Denver, showcasing the society's worldwide impact on reproductive medicine.

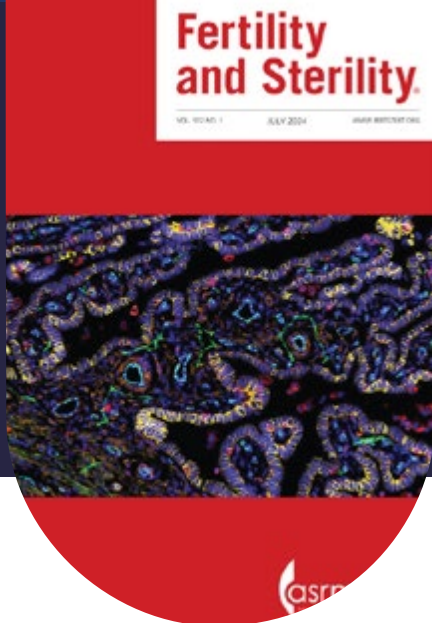

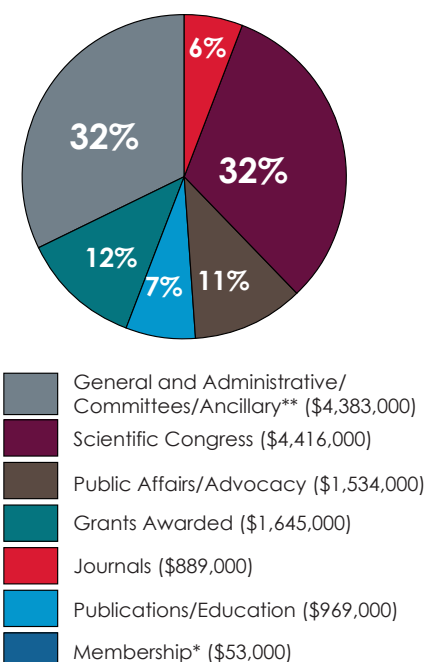

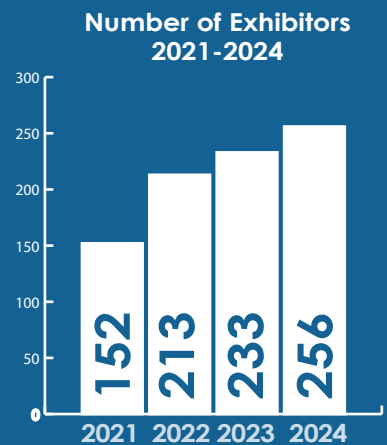

Looking Forward

A Message from ASRM President Elizabeth Ginsburg, MD

Greetings! This past year was eventful, and ASRM has been extremely productive. We completed the development of our new strategic plan, and I would like to highlight some important areas that we will focus on in 2025.

Advocacy

Advocacy for reproductive care will clearly be even more critical during the current administration. Through the efforts of our advocacy team and our members and patient advocates, California passed a mandate to cover infertility treatment. However, bills with potentially negative impacts on IVF care are being proposed in quite a few states, and ASRM efforts are underway to combat these.

To train our members to counter restrictive legislation in their states, the CPL has initiated the PRIMED (Preparing Experts in Reproductive Medicine to Engage Decisionmakers) program. This seven-month course is open to all ASRM members and includes a trip to Washington, D.C., to teach effective advocacy. The first cohort of graduates has been extremely productive, and we have already recruited our second cohort for 2025.

Workforce Development

Indications for IVF treatment have been expanding, and increasing numbers of individuals require it. However, access to care remains an issue, in part due to an inadequate number of skilled embryologists. ASRM and its affiliate organization, the Society of Reproductive Biologists & Technologists (SRBT), are proud to partner in the development of an embryology school, the Clinical Embryology Learning Laboratory (CELL).

CELL will assist SART clinics by training newly hired embryologists. The 10-month curriculum includes 10 weeks of hands-on simulation and has been designed to teach junior embryologists the skills they need to quickly integrate into their laboratory practices.

In other workforce development efforts, the number of ACGME-approved REI fellowship programs is increasing, and the Society for Reproductive Endocrinology and Infertility (SREI) is creating a core curriculum that REI fellowships can utilize to ensure consistent, high-quality training. This will position graduates not only to pass their board exams but also to flourish in their careers and be more productive in our field.

Global Collaboration

Improving reproductive care for all is a core mission of ASRM. To improve access to care globally, it is critical to lend our expertise to countries that are earlier in the development of infertility and IVF care. The theme of the ASRM 2025 Scientific Congress & Expo is "Global Collaboration to Advance Reproductive Care." As such, we will highlight collaborative efforts to improve reproductive care and reproductive research.

We plan to continue our partnership with the World Health Organization (WHO), and ASRM leadership will continue to volunteer their time to teach hands-on courses in embryo transfer with the ASRM-developed embryo transfer simulator in countries within Africa and the Middle East.

Research

Reproductive care cannot advance without research, and the ASRM Research Institute continues to support research that will not be covered by the NIH. Unfortunately, the list of reproductive medical topics excluded by the NIH is continuing to grow. Therefore, increasing the Research Institute's endowment is more critical than ever.
