Paul is an Australian mining engineer who has spent more than a decade steering commercial strategy on multi-billion-dollar mining projects across Australia and Africa. Early in his career he held senior contract and commercial management roles with tier-one contractors, where he routinely negotiated complex EPC and alliance agreements, led cost-recovery strategies, and navigated high-stakes disputes.
