Amanecer began to serve our communities on August 17, 1975. Our mission continues and endures: to deliver compassionate, innovative mental health services to empower individuals and families to overcome barriers and significant life challenges to achieve more fulfilling, resilient, and self-sufficient lives.

## Who We Serve

Amanecer's clients are low-income community members facing mental health challenges. Many clients' struggles are compounded by food insecurity, language barriers, lack of education, neighborhood violence, immigration issues, domestic abuse, substance abuse, and employment struggles.

Amanecer is proud to be among the few agencies in the downtown Los Angeles area that can treat entire families in-house, as our four clinics host thirteen specialized programs for people of all ages with mild to severe mental health needs. For over 45 years, we have kept an amazing rapport with the Latinx community and have received countless referrals from family members and friends of previous patients.

Our clients and their families reside within Service Areas 4 and 6 in Los Angeles County. Zip codes include neighborhoods in Central and Downtown Los Angeles, including Pico-Union, South Central, Hollywood, Eagle Rock, Highland Park, Lincoln Heights, Boyle Heights, Los Feliz, Mid-City, East LA, Baldwin Hills, and Koreatown.

Amanecer believes that the diversity of our staff should reflect the communities we serve. Approximately 38% of clients speak Spanish as their primary language, and 79% of all ACCS clients identify as Latinx. As such, 85% of our staff are bilingual Spanish speakers. The agency makes every efforts to hire individuals from the neighborhoods we serve. Dear Amanecer Family,

## Trauma Recovery Center

The TRC provides assertive outreach, clinical case management, therapy, psychological testing, psychiatric care, and medication management to victims of crime, including individuals in DCFS and the criminal justice system.

## Trauma Recovery Center Regional

The Trauma Recovery Center at Amanecer was awarded the California Victims' Compensation Board (CalVCB) Pilot Regional Grant in January 2023, and it was officially live as of June 2023! In partnership with Mercy Hospital and St. Joseph's Medical Center Dignity Health, telehealth services are now being offered in the Bakersfield and Stockton areas. The TRC team also hosted its first Community Resource Fair, with more than ten different service providers. Some include Para Los Ninos, LA Family Housing, Neighborhood Legal Service of Los Angeles, and the District Attorney's Office.

We are excited to continue our partnership with CalVCB and to serve even more members of our community.



## **Domestic Violence Program & Graduation**

Amanecer's Domestic Violence program, The First Step Forward, offers a safe and judgment-free space for victims to become survivors through individual, family, and group therapy; intensive case management; parenting and life skills training; and access to employment, education, and job-training resources to individuals who have been traumatized by abuse in the home.

Thanks to the generosity of foundations and donors, annually Amanecer can assist approximately 50 individuals seeking to transition away from DV situations.

Amanecer's First Step Forward Program annually hosts a Domestic Violence Graduation to honor our Domestic Violence survivors. We are happy to say that our 2023 DV Graduation was held in person, after three years of being hosted virtually. The formal ceremony was catered, and DV Grad gift bags were given to our 13 graduates.

Domestic Violence graduates have undergone difficult mental and emotional work to regain confidence, relearn self-sufficiency, and break the cycle of abuse. We invite you to learn more about our Domestic Violence program by scanning the QR code below.

## **Clinical Programs**

Our Clinical Programs provide an array of compassionate, preventative, and culturally competent mental health services to children from birth to 5 1/2 through the Child Parent Psychotherapy model, children transition-age youth (TAY), ages 16-25, and adults from 25-60+. Services are focused on collaboratively creating specialized treatments for each client's needs and goals utilizing evidence-based practices. Services include psychotherapy, case management, and medication support.

## **Community Based Programs**

Amanecer's Community Based Programs offer a wide range of compassionate and culturally competent mental health services to children, transition-age youth (TAY) (ages 18-26), and adults (ages 26-60+). Each client is assigned a treatment team consisting of a therapist, case manager, and psychiatrist/nurse practitioner as needed. We ensure that our clients receive quality mental health services tailored to their current needs by enrolling them in a program that provides the appropriate level of care. Services are delivered via telehealth, in the office, in clients' homes, or in the community to address their treatment needs and goals.

Our intensive case management services offer resources to access vocational training, employment, education, housing, and other essential resources to live self-sufficient lives. Our psychiatric team consists of bilingual/bicultural psychiatrists and nurse practitioners who provide medication support services.

## **Client Story**

Jane, a 69 year-old woman, was referred to mental health services at ACCS by a previous therapist who had only been providing medication services. She has been a victim of domestic violence for years and has had unhealthy relationship dynamics with her adult daughters. At the beginning of therapy, Jane was diagnosed with severe Major Depressive Disorder with Bipolar Disorder in partial remission. She reported feeling sad every day, having a poor appetite, only eating 1-2 meals per day, experiencing sleeping difficulties four times a week, and having negative repetitive thoughts 4-5 times a week and 1-2 times a day.

Jane's symptoms have been affecting her health. She has been experiencing loss of appetite, poor sleep, difficulty managing negative thoughts, and frequent distress. Her negative thoughts include selfblame for current family dynamics and situations. She questions herself, wondering what she did wrong or what she did to deserve mistreatment, especially from her adult daughters. As she feels guilty about her effectiveness as a mother.

Since starting services in early August 2023, Jane has made significant progress. She has improved her self-esteem, set boundaries with dysfunctional family patterns, engaged in self-care activities, used healthy coping skills, and made progress with her appetite. Additionally, she has reduced cognitive distortions related to ineffective motherhood and worked with her therapist to address domestic violence and emotional abuse. As a result, Jane reported a decrease in depressive and mood symptoms. She is proactive in continuing to make progress, feeling empowered to engage in meaningful activities, and is mindful not to regress to unhealthy family dynamics. Jane enjoys interacting with neighbors, spending time with her pets, engaging in exercises, and visiting her favorite stores and restaurants.




