#### **Navigating financial challenges**

#### The impact of rising costs on Northern Ireland's clubs

Registered private member sports, social, and recreational clubs throughout Northern Ireland will soon face increased financial pressures due to upcoming changes to Employers' National Insurance and the National Minimum Wage. These changes could place additional strain on clubs already contending with rising energy costs, supply chain issues, and ongoing economic uncertainty. Clubs that employ staff will need to carefully review their budgets to accommodate the higher wage requirements, ensuring they remain compliant with the new regulations while maintaining financial stability.

It is acknowledged that the hospitality sector, in particular, continues to endure tremendous challenges, with Hospitality Ulsters's, Colin Neill, maintaining a high profile in representing his sector members. The increased wage burden may lead to difficult decisions regarding staffing levels, operating hours, or membership fees. Likewise, the NIFC remains committed to addressing queries through our helplines and email facilities, providing guidance and support to clubs navigating these changes. Clubs are encouraged to seek advice on cost-saving strategies and potential funding opportunities that may help offset some of the financial pressures.

While clubs may be able to adapt due to the volunteer aspect of the sector, these remain very challenging times. The increase in the National Minimum Wage will directly impact payroll costs, and the rise in Employers' National Insurance contributions from 13.8% to 15% will further add to the financial burden. Additionally, the threshold at which employers start paying NI contributions will decrease from £9,100 to £5,000 per year, impacting many smaller clubs. Although the government has announced an increase in the Employment Allowance from £5,000 to £10,500, this will only provide relief to some employers, and clubs must carefully assess how these changes affect their financial sustainability. Additionally, clubs should consider conducting financial audits to identify areas where efficiencies can be made without compromising the quality of services provided to members.

Added to this is the news that the government will be cutting disability benefits, a move that may unfortunately impact individuals who genuinely need the assistance they currently receive. Many clubs offer vital social spaces for individuals with disabilities, providing

a sense of community and support. The reduction in benefits could lead to decreased participation in club activities, affecting both the individuals and the clubs that rely on steady membership engagement. The media has highlighted the substantial increase in government spending on this sector since COVID, but concerns remain about the impact of these cuts on vulnerable individuals.

It was recently reported on our Facebook page that clubs making rule changes or appointing new committee members are required to notify the Clerk of the Court and the Sub-Divisional Commander of their area. This is a requirement that may sometimes be overlooked, and we advise club management committees to remain mindful of their obligations. Ensuring compliance with these legal requirements helps maintain smooth operations and avoids potential issues down the line. A Federation colleague has engaged with Constable Paul Larkin in the North West on this matter, and while a hard line is not being taken, clubs are advised to comply appropriately. Keeping up with regulatory requirements and engaging with relevant authorities ensures that clubs can continue to operate successfully while focusing on their primary mission - serving their members and the wider community.

# Important updates on statutory payment rates from April 2025

As of April 2025, several important updates to statutory payment rates will take effect in Northern Ireland. Businesses should be aware of the following changes:

#### National Minimum and Living Wage Increases

Effective from 1st April 2025, the National Minimum Wage (NMW) and National Living Wage (NLW) rates will rise as follows:

- National Living Wage (ages 21 and over): Increases from £11.44 to £12.21 per hour.
- Ages 18-20: Rises from £8.60 to £10.00 per hour.
- Ages 16-17 and Apprentices: Both see an increase from £6.40 to £7.55 per hour.

#### Statutory Sick Pay (SSP) Starting 6th April 2025, the

Starting 6th April 2025, the SSP rate will increase:

• SSP Rate: Will rise from £116.75 to £118.75 per week.

Additionally, the lower earnings limit, relevant for qualifying for certain statutory payments, will be set at £125 per week.

#### Statutory Maternity, Paternity, Adoption, and Shared Parental Pay

From 6th April 2025, the following statutory payments will increase:

- Statutory Maternity Pay (SMP): Increases to £187.18 per week.
- Statutory Paternity Pay (SPP): Increases to £187.18 per
- Statutory Adoption Pay (SAP): Increases to £187.18 per week.
- Statutory Shared Parental Pay (ShPP): Increases to £187.18 per week.

#### Employer National Insurance Contributions (NICs)

From April 2025, Employer NICs will undergo significant changes:

- Contribution Rate: Will rise from 13.8% to 15%.
- Threshold Reduction: The salary threshold at which employer NICs become payable will decrease from £9,100 to £5,000 per annum.
- Employment Allowance: Will increase from £5,000 to £10,500, providing some relief to eligible employers.

#### Small Employers' Relief (SER)

The compensation rate for Small Employers' Relief on statutory payments will increase from 3% to 8.5%, effective 6th April 2025. This adjustment aims to assist small businesses in managing the increased costs associated with statutory payments.

#### Good Jobs Employment Rights Bill

Unlike Great Britain, where the Employment Rights Bill is being introduced, Northern Ireland is progressing with the Good Jobs Employment Rights Bill. This bill aims to improve working conditions and protections for employees across the region. Key provisions include:

- Improving Terms of Employment: Establishing mandatory minimum standards for wages, health benefits, and paid leave to ensure fair compensation and working conditions.
- Supporting Work-Life Balance: Introducing measures to assist working families, such as flexible

working arrangements and enhanced leave policies.

• Enhancing Employee Representation: Strengthening the voice and representation of employees in the workplace by facilitating union access and participation in workplace discussions.

The consultation period for the Good Jobs Employment Rights Bill concluded on 30th September 2024, and the Department for the Economy is currently reviewing feedback from various stakeholders before finalising the legislation. Businesses in Northern Ireland should follow the bill's progress, as it will introduce new employment standards and practices that employers must comply with.

These updates underscore the importance for businesses in Northern Ireland to stay informed and adapt to evolving employment laws and statutory obligations. Proactive measures, such as keeping up to date with emerging legislative changes and updating policies, can help mitigate potential challenges arising from these changes.

remains immeasurable. We look forward to seeing him at future events and hearing the stories of his next adventures.



We continually say that those who prepare best suffer less, and this development at Whitehouse



Q. The committee are considering introducing the following as a bye-law: 'Acceptance to the committee, no member shall be allowed to stand for the committee if they have business interest within the club (e.g. catering franchise) and/or partner already serving on the committee.' Would this be an acceptable

**A.** We would suggest that this would properly be dealt with as a rule change rather than a bye-law.

bye-law?

It essentially conflicts with the existing rules which allow any member to stand for election to the committee as long as they have been a member for a minimum period of time. In the event of a conflict between a bye-law and a rule then the rule will override the bye-law.

You would want to therefore incorporate this into the existing qualifying provisions for committee elections and it will have to be approved by the members as a formal rule change.

Whether or not this can be accomplished prior to the AGM depends on how soon the SGM

can be held and the date of the AGM.

You may also want to be sure of the wording of the rule and have in place a mechanism for dealing with a dispute over what constitutes a business interest or relationship - does a casual relationship count for example? It may sound frivolous, invariably these type of fringe cases will occur at some point. The current wording also leaves open the question of what would happen if a husband and wife who were not already committee members both stood for election at the same time. What happens if the members elect them both? It sounds like you had a very specific instance of one couple being on the committee and this couple also had business interests in the club. The committee may wish to ask themselves how often this scenario is likely to occur and if it really needs a rule amendment to legislate for it. Arguably it would be easier not to award contracts or business interests to members in the first place and not to accept membership applications from persons with pre-existing business interests in the club

Husbands and wives, for example, may vote the same way but equally so may two good friends. Where do you draw the line and, indeed, is it even imperative to draw a line? Equally, the idea that a husband and wife would always vote the same way is somewhat antiquated in any event.

In short, this would have to be done as a rule amendment but we do suggest that the committee thinks very carefully before proceeding. A poorly worded rule amendment usually causes more problems than the original situation it was trying to solve.

Q. We are reviewing our membership structure and considering introducing a probationary period for new members. Would this be possible?

A. Whilst probationary membership would be difficult to introduce, a temporary membership is possible and could be used to similar effect. In theory, you could use a temporary membership option as a de facto probationary membership if you were so inclined. Elect persons for one month and when this automatically ends they can then apply for full membership.

You would obviously need to decide if you were going to make all new members opt for

temporary membership first before offering them permanent membership - this may be off-putting to some potential members and therefore counter productive regarding the recruitment of new members.

Have you frequently had problems with new members and disciplinary issues? It is important to establish the scale of the current problem which will dictate a sensible solution.

Obviously, being careful about who the committee elect to membership to start with is one way of trying to prevent future problems from emerging.

Membership recruitment is the primary objective of any successful club, so I think we have to be careful not to lose sight of this or make it too difficult for prospective members to join.

#### The Licensing and Registration of Clubs (Amendment) Act (Northern Ireland) 2021 - Section 43 - Review

The following text was posted to the Federation Facebook page recently, but for those of you not on social media we have included it in this month's Review for your attention. We encourage clubs to follow the weblink at the end of the editorial and complete the survey.

With regards the Licensing and Registration of Clubs (Amendment) Act (Northern Ireland) 2021 ('the Act') amended the Licensing (Northern Ireland) Order 1996 and the Registration of Clubs (Northern Ireland) Order 1996. The provisions in the Act were brought into operation in phases, with the first

commencing on 1st October 2021 and the last on 6th April 2023.

Section 43 of the Act requires the Department to review and report on the implementation and effectiveness of each provision in the Act as soon as is practicable after the third anniversary of the commencement of that provision and thereafter, at least once in every five years.

The Department is required to lay each of these reports before the Assembly and must then publish the reports.

The Department is currently gathering information for the first review which will report on the provisions which were commenced on 1st October 2021. This includes the launch of online surveys to capture the views and experiences of those who may have been impacted by those changes.

The surveys, which are now available for completion on Citizen Space, opened on 17th February 2024 and will close on 13th April 2025. These can be found on the Departmental S43 Review webpage at https:// www.communities-ni.gov.uk/ consultations/first-review-licensingand-registration-clubs-amendmentact-northern-ireland-2021 with some further details about the review.

The Department is keen to reach out to as many people as possible, and we would encourage clubs to engage with this if possible.





# Couple behind Antrim Coast Half Marathon share touching origins of the race

Since its inception in 2020, the Antrim Coast Half Marathon has become an international sensation. The race, which began with just 62 participants, now attracts almost 6,000 participants, with world-class athletes traveling from around the world to compete.

However, for the race creators, married couple Ruth and James McIlroy from Larne, the race is about more than just running.

James, a former Olympic middle-distance runner, and Ruth, an international rowing coxswain and runner, have long been immersed in the world of competitive sports. Their personal connection to the Antrim Coast is central to the race's design and success.

James McIlroy, Race Director, Antrim Coast Half Marathon, said, "Ruth and I have extensive experience in competitive sports.
