### 1. Who We Are and Our Regulatory Compliance

Data Controller:

Letsbuyhealthcare Limited – Company no. 604764 is a "for profit" company registered in the Republic of Ireland. We operate a comparison website providing details of suppliers and related private healthcare services & treatments to consumers.

For the purposes of the General Data Protection Regulation (EU) 2016/679 (**GDPR**), we are the **Data Controller** of your personal information. Our Commitment:

#### 3. Definitions

- "We," "Our," or "Us" means Letsbuyhealthcare Limited.
- "Personal Information" means any information or opinion about you from which your identity is apparent, or can reasonably be ascertained, regardless of whether the information or opinion is true or recorded in a material form. This includes any photographs or information you upload on our website.

## 5. Disclosure and Sharing of Personal Information

We will disclose your personal information:

- 1. **To Third-Party Providers:** To facilitate the offer and arrangement of your requested healthcare services.
- 2. **To Service Providers:** To contractors, agents, or third-party service providers (e.g., IT hosting, payment processors) who assist us in operating the website and delivering services. They are bound by contract to protect your data.
- 3. **For Legal Reasons:** Where required by law, court order, or governmental regulation.

You specifically consent to receiving electronic communications from us or a Third-Party Healthcare Provider regarding the offer and arrangement of your healthcare. Should you not wish to receive such notifications, please contact us via the details at the end of this Statement.

### 6. Your GDPR Data Subject Rights

As a data subject under GDPR, you have the following rights regarding your personal information:

- Right of Access: To request a copy of the personal data we hold about you.
- Right to Rectification: To have inaccurate data corrected.
- Right to Erasure ('Right to be Forgotten'): To request that we delete your data where there is no longer a legal basis for holding it.
- **Right to Restriction of Processing:** To block or suppress the processing of your data.
- **Right to Data Portability:** To receive your personal data in a structured, commonly used, and machine-readable format.
- Right to Object: To object to processing based on legitimate interests or for direct marketing.
- **Right to Withdraw Consent:** To withdraw your consent at any time, where consent is the legal basis for processing.

## 7. Data Security and Retention

**Security:** We are committed to maintaining appropriate physical, technical, and administrative security measures to protect your personal information against accidental or unlawful destruction, loss, alteration, unauthorized disclosure, or access. The information you supply will be held by us on a computer database or may be held by us in any other way.
