SLSLS provides free legal services to survivors seeking protection from Intimate Partner Violence (IPV). In St. Louis County, less than 10% of survivors who seek legal protection from their abusers have representation. Shockingly (but not surprisingly), 80% of petitions for Orders of Protection in St. Louis County are dismissed. In many instances, this is because their abusers have intimidated or coerced them not to appear for their trials. SLSLS was founded to ensure that survivors of IPV will come to court – with a lawyer by their side.

In just two and a half years, our dedicated staff and volunteer attorneys have helped more than 400 survivors get the assistance they need. This includes representation at more than 300 hearings, obtaining life-saving Orders of Protection, and safeguarding more than 220 children in the process. We've

built partnerships with more than 30 community organizations to provide wraparound services that extend far beyond the courtroom. Together, we are changing what safety and justice look like in St. Louis.

We are excited about our third annual fundraiser on October 16th, which will honor the legacy of our dear friend and supporter, Jim Holloran. (See details on page 2.) This year's event will feature some of the courageous survivors that SLSLS has represented. We will also recognize several volunteers who have gone above and beyond in their service to our clients. (See details on page 4.)

Jan's Story

The last six years of my 36-year marriage were toxic. The man I once loved changed my life into a daily nightmare. Every day was unpredictable and filled with relentless verbal abuse. My three adult children urged me to leave, but with little money and no clear plan, I felt trapped. I retreated to the second floor of our home, the only place I felt a bit of peace.

One night, I heard a gunshot downstairs. I froze, terrified he might shoot me if I went to help. The next morning, I learned it was just a scare tactic. I started staying late at work to avoid going home. Then one day, he sent me three suicidal text messages. I called the police, who told me I needed an Order of Protection (OP) because situations like this can escalate into murder-suicides.

Two weeks later, I faced him in court alone while he had a lawyer. A court advocate suggested I contact SLSLS. I didn't think anyone would understand the mental abuse I'd endured since I had no visible bruises. But from that day forward, everything changed. SLSLS gave me a lawyer who understood my situation, supported me, and helped me prepare for court. Their staff answered my every question and made me feel less alone.

The OP was granted, and I could finally sleep without fear. SLSLS helped me find the confidence to file for divorce, and even represented me in extending the OP so it wouldn't expire. SLSLS changed my life, and I'm forever grateful. After I retire, I plan to give back by volunteering with them.
