Court Appointed Special Advocates (CASAs) make a life-changing difference for children who have experienced abuse or neglect. At the heart of CASA's work is the one-on-one advocacy that our volunteers provide. Each CASA volunteer typically takes on one case or one sibling group at a time. This intentional approach allows for deep, meaningful engagement with each child. Unlike other professionals in the child welfare system, who may manage numerous cases, CASA volunteers can truly know each child and their unique needs. They meet with the child, speak to family members, school staff, healthcare providers, and others involved, gathering insights that inform the court and support the child's best interests. CASA volunteers stay with their cases until they reach permanency, offering children a consistent, positive presence during times of significant upheaval. **For many children, their CASA volunteer is the only constant in a system that often changes rapidly around them.**
